Subject: Notice for hearing on 5th July, 2012 (Thursday) at 02:00 PM.

WHEREAS under Section 19(3) of the Right to Information Act, 2005, the Nagaland Information Commission have received a second appeal dated 22.03.2012 from appellants, (i) Mrs. Neilakuo-ü, President of Nurses of FHW(ANM), NHA Kohima, (ii) Mrs. Neikonuo, Vice-President of Nurses of FHW(ANM), NHA Kohima and (iii) Ms. Imtimerenla, Secretary of Nurses of FHW(ANM), NHA Kohima, wherein the appellants stated that their first appeal dated 12.01.2012 heard on 08.02.2012 by the Principal Director & First Appellate Authority, Directorate of Health & Family Welfare, Nagaland, Kohima and thereafter decision communicated vide No. DHFW-19/Appeal-1/2012/11093 dated 09.02.2012 was unsatisfactory;

AND WHEREAS the first appeal dated 12.01.2012 was preferred to the Principal Director & First Appellate Authority, against unsatisfactory information provided by the Additional Drugs Controller & PIO, Directorate of Health & Family Welfare vide No. DHFW-19/RTI-NHAK/2011/10300 dated 19.12.2011 to their RTI application dated 02.12.2011;

AND WHEREAS there was no response from the Medical Superintendent & PIO, NHA Kohima to whom the RTI application was transferred by the Additional Drugs Controller & PIO, Directorate of Health & Family Welfare vide No. DHFW-19/RTI-NHAK/2011/10301 dated 19.12.2011;

AND WHEREAS the Commission directed the Principal Director & First Appellate Authority, Directorate of Health & Family Welfare to furnish satisfactory information to the applicants (now appellants) within 30 days from the date of receipt of the Commission's directive vide No. NIC/Appeal-22/2011-12/140 dated 03.04.2012;

AND WHEREAS the Principal Director & First Appellate Authority, Directorate of Health & Family Welfare, vide No. DHFW-19/Appeal-1/2012/593-96 dated 02.05.2012, informed that all doubts were clarified with the documentary supports during the first appeal hearing held on 08.02.2012 in the presence of all the concerned section incharges(officers) and the appellants;

AND WHEREAS the Nagaland Information Commission has decided to hear the appeal, giving opportunity to the parties on 5th July, 2012 (Thursday) at 02:00 PM in the Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.
