Sub: Closing Order of Appeal Case.

WHEREAS, under Section 19 of the RTI Act, 2005 and in accordance to the Nagaland Information Commission (Appeal Procedure) Rules-2005, the Commission had heard the second appeal dated 14.02.2019 for the second time on 04.09.2019 at 12:00 Noon jointly submitted by (i) Shri. Abel, (ii) Shri. Puloto and (iii) Shri. Akashe, Mobile No.9862290250/ 8837369415/ 9402087117 against the unsatisfactory and misleading of the information furnished by Er. Achakbou, Superintendent Engineer (Agri) in response to their First Appeal dated 10.01.2019 which was submitted against the non-response of the PIO, Directorate of Agriculture, Nagaland, Kohima to their RTI application dated 20.11.2018.

AND WHEREAS, after the second hearing held on 04.09.2019 at 12:00 Noon, the Commission had passed decision of even No. dated 10.09.2019.

AND WHEREAS, in compliance to the decision of the Commission dated 10.09.2019, Shri. K. Remphamo Lotha, Joint Director & PIO, Directorate of Agriculture, Nagaland, Kohima had, vide letter No.AGR/RTI-2/APPEAL/2016-17 dated 24.09.2019 forwarded a copy of Treasury Challan No.4 dated 19.09.2019 for an amount of ₹7,500/- (Rupees Seven Thousand Five Hundred only) towards penalty imposed on Er. Achakbou Newmai, Superintending Engineer and Er. Manjo Katiry, Junior Engineer @ ₹3,750/- each for contributing to the delay of thirty (30) days in furnishing the information to the applicants (now appellants).

AND WHEREAS, as decided in the last hearing, since the above compliance have been received and that the applicants (now appellants) had expressed their satisfaction vide letter dated 31.08.2019 with the information furnished by the Joint Director & PIO, Directorate of Agriculture, the Commission has decided to close the Appeal case.


