

**Sub: Closing Order of Appeal Case.**

WHEREAS, under Section 19 of the RTI Act, 2005 and in accordance to the Nagaland Information Commission (Appeal Procedure) Rules-2005, the Commission had heard the second appeal dated 15.03.2019 received from Smti. Akokla, Hill View Colony, Dimapur, Nagaland, Mobile No.9436061260/ 8416043504 against the non-satisfaction of the decision of the Deputy Commissioner & FAA, Dimapur, Nagaland to her first appeal dated 24.07.2018 which was submitted against the incomplete and non-satisfactory of the information furnished by Shri. Albert Ezung, Additional Deputy Commissioner & PIO, Dimapur, Nagaland in response to her RTI application dated 07.06.2018.

AND WHEREAS, after the hearing held on 07.05.2019 at 12:30 P.M., the Commission had passed decision of even No. dated 24.05.2019.

AND WHEREAS, in compliance to the Point No.1 of the decision of the Commission dated 24.05.2019, Smti. Mhalo Humtsoe, NCS, Revenue-cum-Resettlement Officer, O/o the Deputy Commissioner, Dimapur, Nagaland had, also vide letter No. NIL dated 07.06.2019 submitted to the Commission a copy of a sworn affidavit bearing Regd. No. 101/ 2019 dated 07.06.2019 declaring that the information sought by the applicant (now appellant), Smti. Akokla, could not be provided as the records are not available in the office.

AND WHEREAS, in compliance to the Point No.2 of the decision of the Commission dated 24.05.2019, Smti. Mhalo Humtsoe, NCS, Revenue-cum-Resettlement Officer, O/o the Deputy Commissioner, Dimapur, Nagaland had, vide letter No. NIL dated 07.06.2019 submitted to the Commission a copy of Treasury Challan No. 16 dated 12.06.2019 for the penalty amount of ₹500/- (Rupees Five Hundred only) which was imposed on Smti. Kemciyile, NCS, SDO (C) & APIO, O/o the Deputy Commissioner, Dimapur, Nagaland.

AND WHEREAS, as decided in the last hearing, since the above compliances have been received, the Commission has decided to close the Appeal case.


