Sub: Closing Order for Appeal Case.

WHEREAS, under Section 19 of the RTI Act, 2005 and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules-2005, the Commission had heard the second appeal dated 19.07.2017 for the fourth time on 08.05.2019 at 11:30 P.M. which was submitted by Shri. Prem Rattan Daga, M/s R.D. Trade Agency, C/o M/s Monika (Bombay Dyeing) Church Road, Dimapur 797112 against the non-response of the FAA, PHED to his first appeal dated 06.12.2016 which was submitted against the non-response of the PIO to his RTI application dated 08.09.2016.

AND WHEREAS, after the fourth hearing held on 08.05.2019 at 11:30 P.M., the Commission had passed decision of even No. dated 29.05.2019.

AND WHEREAS, in compliance to the decision of the Commission dated 29.05.2019, Er. Repangyangba Longkumer, Additional Chief Engineer & PIO, O/o the Chief Engineer, PHED, Nagaland, Kohima had, vide letter No.CE/PHE/RTI/2005 dated 12.06.2019 submitted to the Commission a copy of Treasury Challan No. 3 dated 07.06.2019 for the penalty amount of ₹12,500/- (Rupees Twelve Thousand Five Hundred only) imposed on him.

AND WHEREAS, also in compliance to the decision of the Commission dated 29.05.2019, Er. N. Yanger Pongen, Executive Engineer & PIO, PHED, Mokokchung, Nagaland had, vide letter No.EE/PHE/MKG/RTI/2007-08 dated 07.06.2019 submitted to the Commission a copy of Treasury Challan No. 1 dated 07.06.2019 for the penalty amount of ₹12,500/- (Rupees Twelve Thousand Five Hundred only) imposed on him.

AND WHEREAS, as decided in the last hearing, since the above compliances have been received, the Commission has decided to close the Appeal case.


