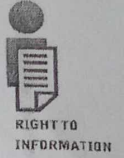

Sub: **Closing Order for Appeal Case.**

WHEREAS, under Section 19 of the RTI Act, 2005 and in accordance to the Nagaland Information Commission (Appeal Procedure) Rules-2005, the Commission had heard the second appeal dated 11.01.2018 received from Shri. Navin Kumar, C/o P.C. Rai, Hanuman Nagar, Milki Ainith, Ara, Bhojpur, Bihar, Pin-802301, Mobile No. 9334166175 against the non-response by the First Appellate Authority, Home Department, Nagaland, Kohima to his first appeal dated 08.08.2017 which was preferred against the non-furnishing of satisfactory information furnished by the PIOs of the Deputy Commissioner's Offices (excepting Mokokchung and Wokha) to his RTI application dated 03.02.2017 which was transferred from the Home Department.

AND WHEREAS, after the second hearing held on 07.05.2019 at 1:30 P.M., the Commission had passed decision of even No. dated 16.05.2019.

AND WHEREAS, in compliance to the decision of the Commission dated 16.05.2019, the Commission had received the penalties from the following PIOs/ Deemed PIOs:

1. Treasury Challan No.29 dated 14.06.2019 for the penalty amount of ₹2342/- (Rupees Two Thousand Three Hundred Forty Two only) from Smti. Lithrongla Tongpi Rutsa, NCS, ADC & PIO, O/o the Deputy Commissioner, Kohima vide letter No.DCK/ADC/RTI/2018/873 dated 17.06.2019.
2. Treasury Challan No.30 dated 14.06.2019 for the penalty amount of ₹8819/- (Rupees Eight Thousand Eight Hundred Nineteen only) from Shri. Kisumong Tikhir, NCS, former ADC & PIO, O/o the Deputy Commissioner, Kohima (now posted as ADC, Satakha) vide letter No.DCK/ADC/RTI/2018/873 dated 17.06.2019.
3. Treasury Challan No.1 dated 13.06.2019 for the penalty amount of ₹11,161/- (Rupees Eleven Thousand One Hundred Sixty One only) from Shri. Vekhoyi Chakhesang, ADC & PIO, Zunheboto, O/o the Deputy Commissioner, Zunheboto.

AND WHEREAS, since the Commission had not received any compliance regarding the penalty from Shri. Hotolu Swu, NCS, former ADC & PIO, the Commission had vide letter of even No. dated 18.09.2019 reminded him to pay/ deposit the penalty amount failing which show cause notice would be served recommending disciplinary action as per service rules applicable under section 20 (2) of the RTI Act, 2005.

AND WHEREAS, in compliance to the above reminder, the Commission had received Treasury Challan No.18 dated 20.09.2019 for the penalty amount of ₹2,678/- (Rupees Two Thousand Six Hundred Seventy Eight only) from Shri. Hotolu Swu, NCS, former ADC & PIO, O/o the Deputy Commissioner, Wokha (now posted as Joint Secretary, Soil & Water Conservation Department, Nagaland Civil Secretariat, Nagaland, Kohima).

AND WHEREAS, since all the above compliances have been received from the Public Authority and there was no response from the applicant (now appellant), though sufficient time had lapsed, suggesting that the applicant (now appellant) have no interest to pursue his case further, the Commission has decided to close the appeal case.

NOW THEREFORE, it is notified to all the parties that this Appeal case is hereby declared as closed:-


