**Sub: Closing Order of Complaint case.**

WHEREAS, under Section 19 of the RTI Act, 2005 and in accordance to the Nagaland Information commission (Appeal Procedure) Rules-2005, the Commission had, on 14.03.2019 at 12:00 Noon heard compliant case dated 10.12.2018 received from Dr. Prasanta Kumar Goswami, 1803, Rajdanga Main Road, Block-EF-16, P.O. E.K.T.P., Kolkata-700107, West Bengal against the non-satisfaction of information furnished by Dr.T. Bendangtula, Assistant Director (AYUSH), Directorate of Health & Family Welfare, Nagaland, Kohima in response to his RTI application dated 15.11.2018.

AND WHEREAS, after the hearing held on 14.03.2019 at 12:00 Noon, the Commission had passed decision of even No. dated 22.03.2019.

AND WHEREAS, in compliance to the decision of the Commission dated 22.03.2019, Dr. T. Bendangtula, Assistant Director AYUSH/ Registrar & PIO, Board of Homoeopathic System of Medical Nagaland, Directorate of Health & Family Welfare, Nagaland, Kohima had, vide Notification No.DHFW-18/Homoeo Board/ 2013-14/304 dated 02.04.2019 set up one Inquiry Committee and submitted the findings of the Committee in regard to the question put forth by the applicant (now complainant) vide letter No.DHFW-18/Homoeo Board/ 2013-14/310 dated 17.04.2019.

AND WHEREAS, the Commission had received letter dated 01.06.2019 from the applicant (now complainant) stating that he could not attend the hearing held on 14.03.2019 due to ill health. Further, as per the decision pronounced by the Commission on 14.03.2019 at 12:00 Noon he had requested for a copy of the Inquiry Committee Report set up by the Assistant Director AYUSH/ Registrar & PIO for further reference.

AND WHEREAS, the Commission had, vide letter of even No. dated 28.06.2019 directed Dr. T. Bendangtula, Assistant Director AYUSH/ Registrar & PIO, Board of Homoeopathic System of Medical Nagaland, Directorate of Health & Family Welfare, Nagaland, Kohima to furnish a copy of the Inquiry Committee Report to the applicant (now complainant) and confirm his satisfaction or non-satisfaction of the information so furnished to him within 30 (Thirty) days from the date of receipt of the directive, with a copy to the Commission.

AND WHEREAS, in compliance to the above directive of the Commission dated 28.06.2019, Dr. T. Bendangtula, Assistant Director AYUSH/ Registrar & PIO, Board of Homoeopathic System of Medical Nagaland, Directorate of Health & Family Welfare, Nagaland, Kohima had, vide letter No.DHFW-18/Homoeo Board/2013-14/337-38 dated 11.07.2019 furnished a copy of the Inquiry Report to the applicant (now complainant) and further requested to submit his satisfaction or non-satisfaction of the information so furnished to him.



AND WHEREAS, the Commission had, vide letter of even No. dated 23.08.2019 directed Dr. T. Bendangtula, Assistant Director AYUSH/ Registrar & PIO, Board of Homoeopathic System of Medical Nagaland, Directorate of Health & Family Welfare, Nagaland, Kohima to ascertain the receipt of confirmation from the applicant (now complainant) regarding his satisfaction or non-satisfaction of the information so furnished to him within thirty (30) days from the date of receipt of this directive to enable the Commission close the case.

AND WHEREAS, though sufficient time had lapsed, since there was no response or further complaint from the applicant (now complainant) even after the PIO had furnished the information on 11.07.2019, suggesting that the applicant (now complainant) was satisfied with the information so furnished by the PIO and has no interest to pursue further, the Commission has decided to close the complaint case.

NOW THEREFORE, it is notified to all the parties that this complaint case is hereby declared as closed:-


