WHEREAS, the Commission had, on 09.05.2019 at 1:00 PM heard the second appeal dated 14.02.2019 submitted by (i) Shri. Abel, (ii) Shri. Puloto and (iii) Shri. Akashe, Mobile No. 9862290250/ 8837369415/ 9402087117 against the unsatisfactory and misleading of the information furnished by Er. Achakbou, Superintendent Engineer (Agri) in response to their First Appeal dated 10.01.2019 which was submitted against the non-response of the PIO, Directorate of Agriculture, Nagaland, Kohima to their RTI application dated 20.11.2018.

AND WHEREAS, after the hearing, the Commission had passed decision of even No. dated 24.05.2019.

AND WHEREAS, in compliance to the above decision of the Commission dated 24.05.2019, Shri. K. Remphamo Lotha, Joint Director & PIO, Directorate of Agriculture had, vide letter No. AGR/RTI-1/2019-20/1234-37 dated 03.07.2019 re-furnished the reply to the applicants (now appellants) and with a request to confirm satisfaction with the reply within fifteen (15) days from the date of receipt of the letter.

AND WHEREAS, Shri. L. Hoshito Chophi, Deputy Director & APIO, Directorate of Agriculture had, vide letter No. AGR/RTI-2/APPEAL/2016-17/12-14 dated 30.07.2019 submitted to the Commission stating that the RTI filed by the applicants had been **settled amicably** with the Department of Agriculture and had enclosed a copy of signed **Agreement** dated 26.07.2019.

AND WHEREAS, the applicants (now appellants) had also submitted a letter signed on 27.07.2019 addressed to the PIO, Directorate of Agriculture, Nagaland, Kohima stating that the RTI matter had been settled amicably as per the **Agreement** dated 26.07.2019.

AND WHEREAS, as observed during the last hearing, since there was delay in furnishing the information, the Commission has decided to hear the appeal case giving opportunity of being heard to both the parties on **4th September (Wednesday), 2019 at 12:00 P.M** in the **Hearing Room of Nagaland Information Commission, below Raj Bhavan, Officers' Hill Colony, Nagaland, Kohima.**


