Subject: Closing Order of Appeal Case.

WHEREAS under section 19(3) of the Right to Information Act, 2005, the Nagaland Information Commission had received on 20.08.2019 an Appeal dated 31.07.2019 from Shri. Maran Sarkar, Badharghat, Matripally, P.O- Siddiashram, Agartala, West Tripura – 799003, Email – msarkargt@gmail.com, Mobile No. – 9436454079 stating that he did not receive any reply from the FAA, Office of the Regional Transport Office, Mokokchung, A. M. Road, Nagaland – 798601 against his First Appeal dated 09.01.2019 which was submitted against partial information given by the PIO, RTO, Mokokchung, Nagaland in response to his RTI application dated 14.11.2018.

AND WHEREAS, on receipt of the above Appeal, the Commission had issued a Directive to the FAA vide letter of *even No. dated 10.09.2019* to hear the First Appeal in the presence of the PIO concerned and the applicant (now appellant) and pass decision *within 1 (one) month* from the date of receipt of the directive and submit a copy of the decision to this Commission.

AND WHEREAS, in compliance to the Directive of the Commission of *even No. dated 10.09.2019*, Shri. Elias T. Lotha, Transport Commissioner & FAA, Kohima, Nagaland had summoned the applicant (now appellant) vide letter *No. TC/Estt-RTI/Notice-NIC/306/2014 dated 23.09.2019* to hear the case on 10.10.2019 and thereafter postponed to 29.10.2019 on the request of the applicant (now appellant) vide letter *No. TC/Estt-RTI/Notice-NIC/306/2014 dated 14.10.2019* and postponed further to 11.11.2019 on the request of the applicant (now appellant) vide letter *No. TC/Estt-RTI/Notice-NIC/306/2014 dated 29.10.2019*.

AND WHEREAS, after hearing the First Appeal in the presence of the applicant (now appellant) and the PIO, the FAA had, vide *No. TC/Estt-RTI/Notice-NIC/306/2014 dated 11.11.2019* passed decision, directing RTO & PIO, Mokokchung to furnish all the documents required by the applicant (now appellant) within *10 (ten) days* from the date of hearing decision. The FAA had also directed the applicant (now appellant) to respond whether the responses had been received from the RTO & PIO, Mokokchung within a period of *30 (thirty) days* from the date of issue of the hearing decision, failing which a decision shall be made binding to all parties.

AND WHEREAS, the FAA had also received a copy of the documents furnished by the RTO & PIO, Mokokchung, addressed to the applicant (now appellant) Mr. Maran Sarkar, vide letter *No. RTO-MKG/RTI/G-30/08/8130-33 dated 15.11.2019*, but since there was no response from the applicant (now appellant) even after a lapse of *3 (three) months* to the directive of the Transport Commissioner & FAA vide decision letter *No. TC/Estt-RTI/Notice-NIC/306/2014 dated 11.11.2019*, now, assuming that the applicant (now appellant) has no interest to pursue further, the Transport Commissioner & FAA has decided to close the First Appeal case.

AND WHEREAS, the Commission had vide letter of *even No. dated 09.09.2020* issued a directive to the FAA to confirm satisfaction / non-satisfaction from the applicant (now appellant) *within 30 (thirty) days* from the date of receipt of the directive.

AND WHEREAS, the FAA in compliance to the directive of the Commission had intimated the applicant (now appellant) vide letter *No. TC/Estt-RTI/Notice-NIC/306/2014 dated 28.09.2020*.

AND WHEREAS, since enough/sufficient time had lapsed and there has been no compliance report/correspondence or further response from the applicant (now appellant), the Commission had decided to declare this Appeal case as closed.

NOW THEREFORE, it is notified to the following parties that the Appeal case is hereby declared as **closed**:-


