Subject: Closing Order of Appeal Case.

WHEREAS under section 19 of the Right to Information Act, 2005, the Nagaland Information Commission had received an Appeal dated **11.08.2020** from Shri. Sepili L. Sangtam, President, ENSF & Party, Ph. No. 7005694644 for incorrect, incomplete and misleading information furnished by the Secretary & FAA, Nagaland Public Service Commission (NPSC) to their RTI application No. **NIL dated 16.03.2020** which was submitted to the PIO, NPSC, Nagaland and First Appeal No. **NIL dated 22.06.2020** submitted to the FAA, NPSC, Kohima, Nagaland.

AND WHEREAS, the NPSC had vide letter No. **NPSC/Estt-14/2002 dated 21.07.2020** furnished query-wise replies to the applicants (now appellants).

AND WHEREAS, the Commission had received a letter dated **03.09.2020** from applicants (now appellants) stating that the information so furnished was not satisfactory and incomplete and hence wanted further clarification.

AND WHEREAS, on receipt of the above Second Appeal, the Commission had issued a Directive to the Secretary & FAA, NPSC, Kohima, Nagaland vide letter of **even No. dated 23.09.2020** to hear the First Appeal **within 45 (forty five) days**.

AND WHEREAS, since enough/sufficient time had lapsed and there has been no compliance report/correspondence from the respondents or further response from the applicants (now appellants), the Commission had decided to declare this Appeal case as closed.
