Subject: Closing Order of Complaint Case.

WHEREAS under section 18 of the Right to Information Act, 2005, the Nagaland Information Commission had received a Complaint dated *NIL* on *14.08.2020* from Shri. Robert N Solo, General Secretary & party of Kezekevi Thehou Ba, T. Khel, Kohima Village, Email Add: bobsolo60@yahoo.com, Ph. No. 7005368147 for incomplete information furnished by the PIO to their RTI application dated *28.06.2020*.

AND WHEREAS, on receipt of the above Complaint, the Commission had in reference to the PIO letter No. *NHP/ADMIN-X/2017/4571* of dated *31.09.2020*, issued a Directive to the PIO vide letter of *even No. dated 07.09.2020* to inform the applicants (now complainants) to collect the information (certified true copies) as sought for and thereafter, to confirm satisfaction/non-satisfaction of the information so furnished from the applicants (now complainants) *within 20(twenty days)* from the date of receipt of the directive.

AND WHEREAS, in compliance to the Directive of the Commission of *even No. dated 07.09.2020*, Dr. Imkongtemsu Longchar, Monitoring & Evaluation Officer & PIO, NHP, Directorate of Health & Family Welfare, Kohima, Nagaland had intimated the applicants (now complainants) vide letter No. *NHP/ADMIN-1/2017/4637* dated *11.09.2020* & Email dated *11.09.2020* to come and collect the information as sought for and also to confirm satisfaction/non-satisfaction *within 20(twenty) days w.e.f. 11.09.2020*.

AND WHEREAS, vide application dated *12.10.2020* the applicants (now complainants) had requested the Commission that they are not in a position to comment at this juncture whether the information furnished is satisfactory/misleading/incomplete as it is consuming time to complete perusing the documents which consist of more than *18,000(eighteen thousand) pages*.

AND WHEREAS, since enough/sufficient time have lapsed and there has been no correspondence either from the respondents or the applicants (now complainants), the Commission had decided to declare this Complaint case as closed.
