Subject: **Notice for Hearing on 28th July, 2022 (Thursday) at 11:00 AM.**

WHEREAS, the Commission had received a Complaint dated **30.06.2021** on **03.06.2021** from Shri. **S.T. Yapang Lkr**, RTI Initiative Nagaland, H/No. LA-734, Block-C, Lower Agri Colony, Kohima, Nagaland against the non response of the Public authority to his RTI application dated **30.03.2021**.

AND WHEREAS, the applicant had submitted an RTI application dated **30.03.2021** along with application fee of Rs. 10/- only through Speed Post bearing No. EE407156771IN dated **30.03.2021** seeking the following information:

- i. *What is the actual cost of 1 unit of CGI sheets for PMAY-G scheme till now? Please mention the thickness of the sheets in mm.*
- ii.
 - a) *Will the department distribute the upcoming PMAY-G facilities? Or is it assigned to some other contractor/ supplier?*
 - b) *If it is assigned to some other contractor/ supplier, was there any tender published in the Newspaper? If yes, please mention the name of the Newspaper(s) with date and page number.*
 - c) *How much should it cost a department/ contractor/ supplier for a unit of the CGI sheets? What should be the standard size of the sheets?*
 - d) *How many bundles should 1 unit of CGI sheets consist of?*
- iii. *How much money and what type of housing materials should a beneficiary get from PMAY-G scheme for building a house?*

AND WHEREAS, the above RTI application was received by the department on **12.03.2021** as evidenced from the Tracking ID of the Post Office.

AND WHEREAS, the PIO had failed to furnish the requisite information within the stipulated time frame, the applicant had filed a Complaint dated **30.06.2021** to the Commission which was received by the Commission on **30.06.2021**.

AND WHEREAS, on receipt of the Complaint, the Commission had, vide letter **No. NIC/Gen/RTI-19/17 (Vol-II)/1351** dated **14.07.2021** advised the applicant to file first appeal to the Director & FAA, Rural Development, Nagaland.

AND WHEREAS, since the Commission had not received any compliance from the FAA, it has decided to hear the above mentioned Complaint giving opportunity of being heard to all the parties on **28th July, 2022 (Thursday) at 11:00 AM in the Hearing Room of the Nagaland Information Commission, Agri-Farm Colony, Lane-6, H/No. AFC/578, Nagaland, Kohima.**
