**Dated Kohima, the 10<sup>th</sup> August, 2022**

**Subject: Notice for Hearing on 23<sup>rd</sup> August, 2022 (Tuesday) at 12:00 Noon.**

WHEREAS, the Commission had received a Second Appeal dated **07.04.2021** from **Shri. Abi Senotsu**, H/No. 93, Duncan Basti, Dimapur, M/No. 7005838989, against the non-response of the Deputy Commissioner and FAA, Dimapur, Nagaland to the First Appeal dated **27.10.2020**, which was submitted against the unsatisfactory reply given by the PIO in response to his RTI application dated **07.09.2020**.

AND WHEREAS, the applicant had submitted an RTI application dated **07.09.2020** along with an application fee of Rs. 10/-, and cost of information of Rs. 10/-, to the PIO, Office of the Deputy Commissioner, Dimapur seeking the following information for 2014-2020 *pertaining to acquisition of land of Nuhenuo Ciesotsu at Jharnapani for the 4-Lane highway project:*

- i. The survey report pertaining to the acquisition of land measuring 100x100 ft.*
- ii. Details of the RCC building and other structures standing on the said land.*

AND WHEREAS, on receipt of the RTI application, Er. Nitoli Sema, Executive Engineer, PWD (H) Division, Dimapur had, vide letter **No. EE/HD/TB-RTI/2014/822** dated **18.09.2020**, submitted the information for details of buildings and other structures in respect of Smti. Nuhenuo Ciesotsu to the Revenue-cum-Resettlement Officer, O/o the Deputy Commissioner, Dimapur in response to her letter **No. REV-35/RTI-18-D/7818-19** dated **09.09.2020**.

AND WHEREAS, Smti. Mhalo Humtsoe, Revenue-cum-Resettlement Officer, O/o the Deputy Commissioner, Dimapur had, vide letter **No. REV-35/RTI-18-D/9829-31** dated **19.09.2020** forwarded the letter and enclosure received from the SDO (C) & APIO, O/o the Deputy Commissioner, Dimapur vide letter **No. RTI-10/2018-D/7729-31** dated **07.09.2020** to the District Land Records & Survey Officer, Dimapur with a request to furnish the information sought under *para 1* of the application *on or before 21.09.2020* for onward submission to the applicant.

AND WHEREAS, in response to the letter **No. REV-35/RTI-18-D/9829-31** dated **19.09.2020**, Shri. Zhaphizo, District Land Records & Survey Officer, Dimapur had, vide letter **No. LRSO/D/RTI/2010-11/3545** dated **21.09.2020** forwarded to the Revenue-cum-Resettlement Officer, O/o the Deputy Commissioner, Dimapur, the report submitted by the Surveyor in regard to the RTI case.

AND WHEREAS, Smti. Mhalo Humtsoe, Revenue-cum-Resettlement Officer, O/o the Deputy Commissioner, Dimapur had, vide letter **No. Rev-35/RTI-18-D/7958** dated **22.09.2020** forwarded the replies in para-wise to the SDO (C) & APIO, O/o the Deputy Commissioner, Dimapur, in response to his letter **No. RTI-10/2018-D/7729-31** dated **07.09.2020**.

AND WHEREAS, Smti. V. Lovitoly Sema, ADC & PIO, O/o the Deputy Commissioner, Dimapur had, vide letter **No. RTI-10/2018-D/8291** dated **30.09.2020** forwarded the reply to the applicant.

AND WHEREAS, the applicant had submitted a First Appeal dated **27.10.2020** to the Deputy Commissioner & FAA, Dimapur, Nagaland stating that the required information was not given.

AND WHEREAS, since there was no response to his First Appeal from the FAA, the applicant had submitted a Second Appeal dated **07.04.2021** to this Commission.

AND WHEREAS, on receipt of the Second Appeal by the applicant, the Commission had, vide directive **No. NIC/GEN/RTI-19/19 (Vol-II)/1349** dated **14.07.2021**, directed the FAA to hear the First Appeal within 45 days.

AND WHEREAS, in compliance to the directive of the Commission, Shri. Rajesh Soundarajan, IAS, Deputy Commissioner & FAA, Dimapur had, on **25.08.2021**, heard the First Appeal of the applicant wherein the PIO, O/o the Deputy Commissioner, Dimapur, was directed to furnish the following information to the applicant *on or before 2<sup>nd</sup> September, 2021 positively in consultation with the Revenue Officer, Dimapur.*

- i. Survey report indicating the acquired land and area in sq. ft. along with all the documents pertaining to the acquisition of the said land.*
- ii. Detailed estimate report of the structures assessed by PWD (H) as sought by the applicant.*

AND WHEREAS, Shri. Thejavizo Nakhro, NCS, Revenue-cum-Resettlement Officer, O/o the Deputy Commissioner, Dimapur had, vide letter **No. REV-35/RTI-18D/3180** dated **25.08.2021** submitted the reply in para-wise manner to the SDO (C) & APIO, O/o the Deputy Commissioner, Dimapur in reference to his letter **No. RTI-14/2020-D/FA/3038-40** dated **20.08.2021**.

AND WHEREAS, in compliance to the directive of the FAA, Shri. H. Atokhe Aye, ADC & PIO, O/o the Deputy Commissioner, Dimapur had, vide letter **No. RTI-14/2020-D/FA/3277-80** dated **01.09.2021**, furnished the information to the applicant.

AND WHEREAS, on being dissatisfied with the information furnished by the PIO, the applicant had again submitted Second Appeal dated **22.11.2021** to this Commission stating that the concerned public authority had still not furnished the required information sought.

AND WHEREAS, on receipt of the Second Appeal, the Commission had, vide letter **No. NIC/GEN/RTI-19/17 (Vol-II)/1486** dated **22.02.2022** conveyed its views on the matter as below to the applicant (now appellant):

- i. As per the report of DLRSO vide letter Nos. **LRSO/D/TECH-3/2011-12/161** dated **01.08.2014** & **LRSO/D/TECH-NHDP/2010-11/1241** dated **25.02.2017**, a total of 3000 sq. ft. only was surveyed and acquired.*
- ii. As per the Executive Engineer, PWD (H) report vide letter No. **EE/HD/TB-RTI/2014/223** dated **24.08.2021**, there was no mention of RCC building except for one hill type building, kutcha house, retaining wall, and toilet & septic tank which had been assessed and damages paid.*

AND WHEREAS, since there was no response of the applicant regarding his satisfaction or non-satisfaction, the Commission has decided to hear the above mentioned second appeal giving opportunity of being heard to all the parties on **23<sup>rd</sup> August, 2022 (Tuesday) at 12:00 Noon in the Hearing Room of the Nagaland Information Commission, Agri-Farm Colony, Lane-6, H/No. AFC/578, Nagaland, Kohima.**

NOW THEREFORE, it is notified that the following parties are directed to appear before this Commission and ***also to bring the files and relevant documents*** in question for scrutiny on the above date and time for hearing with preventive measures such as wearing of face mask and social distancing:
