**Subject: Closing Order of Appeal Case.** 

WHEREAS, the Commission had on 24.08.2022 at 11.30 A.M heard the Second Appeal dated 07.09.2021 (received on the same date) submitted by Shri. Kelhuzhato Nakhro, Kohima, Nagaland, M/No. 9612971480.

- AND WHEREAS, after the hearing held on 24.08.2022 at 11.30 A.M, the Commission had passed decision vide even No. dated 14.09.2022.
- AND WHEREAS, in compliance to the Point No. 1 of the above mentioned decision, Shri. Ahozhe Sema, Deputy Director & PIO, Directorate of Land Resources, Nagaland, Kohima had, vide letter No. DoLR/RTI-1/2020 dated 10.10.2022 furnished the complete information free of cost to the applicant (now appellant) with a copy to this Commission.
- 4. AND WHEREAS, referring to Point No. 2 of the decision of the Commission of even No. dated 14.09.2022, no confirmation regarding satisfaction/non-satisfaction of the information furnished by the PIO has been received even after the lapse of 15 (fifteen) days from the date of receipt of the information i.e 10.10.2022, suggesting that the applicant (now appellant) was satisfied with the information.
- AND WHEREAS, referring to Point No. 3 of the decision of even No. dated 14.09.2022, the Commission had issued a Show Cause Notice of even No. dated 17.09.2022 to Shri. Hekato N, Joint Director (The then PIO), Directorate of Land Resources, Nagaland, Kohima to submit a written explanation within 7 (seven) days from the date of receipt of the decision why penalty should not be imposed on him.
- AND WHEREAS, in compliance to the Show Cause Notice of even No. dated 17.09.2022, Shri. A. Pangjung Jamir, Director & FAA, Directorate of Land Resources, Nagaland, Kohima had, vide letter No. DoLR/RTI-1/2015-16/1280 dated 21.09.2022 forwarded the written explanation dated 16.09.2022 submitted by Shri. Hekato N, Joint Director (The then PIO), Directorate of Land Resources, Nagaland, Kohima.
- AND WHEREAS, since the Commission was not convinced with the written explanation dated 16.09.2022, the Commission had issued an Order of even No. dated 12.10.2022 directing Shri. Hekato N, Joint Director (The then PIO), Directorate of Land Resources, Nagaland, Kohima to deposit the penalty amount of Rs. 25,000/- (rupees twenty five thousand only).
- AND WHEREAS, also in compliance to the Order of even No. dated 12.10.2022 and Point No. 3 of the decision of even No. dated 14.09.2022 and Order of even No. dated 12.10.2022, Shri. A. Pangjung Jamir, Director & FAA, Directorate of Land Resources, Nagaland, Kohima had, vide letter No. DoLR/RTI-1/2020/510 dated 20.10.2022 deposited the penalty amount of Rs. 25,000/- vide Treasury Challan No. 1 dated 18.10.2022 (In original) on behalf of Shri. Hekato N, Joint Director (The then PIO), Directorate of Land Resources, Nagaland, Kohima.
- AND WHEREAS, since all the compliances to the decision of the Commission of even No. dated 14.09.2022 have been received, the Commission has now decided to close the Appeal case.

NOW THEREFORE, it is notified to all the parties that this Appeal case is hereby declared as **closed**.
