WHEREAS, the Commission had received a Second Appeal dated *04/11/2022* from Shri. Imkongchingba Phom, Mb- 8787449263, 8416043504, Longleng, Nagaland against incomplete information furnished even after the hearing of the First Appeal dated *06.07.2022* by the Director & FAA, Directorate of Rural Development, Nagaland, Kohima which was submitted against non-furnishing of information by the PIO to his RTI application dated NIL.

AND WHEREAS, the applicant had submitted an RTI application dated NIL alongwith application fee of **Rs.10**/- addressed to the PIO, Rural Development Office, Longleng seeking the following information in in accordance with the RTI Act, 2005 as listed below:-

- 1. Detail beneficiaries list of PMAY under Longleng district (2019-2022). Kindly mention village wise
- 2. Total amount sanctioned/received for PMAY by the Government in the year 2019-2022.
- 3. Mention the current list of all beneficiaries received first or second installment. Kindly specify the amount allocation in first/second/third installment.
- 4. Kindly furnish the utilization receipt of the said scheme amount 2019-2022.
- 5. Name list of all job card holder in Longleng district. Mention village wise. Kindly specify the amount sanctioned by the govt. with the number of days for which payment was released in 2019-2022 and also allocation made to beneficiaries.
- 6. Name list of all beneficiaries under Swatch Bharat toilet scheme 2019-2022. Specify the amount sanctioned by the govt. and also allocation made to beneficiaries.

AND WHEREAS, on receipt of the RTI application dated NIL on 02.06.2022, Shri. M. Chenlong Chenth, BDO, RD Block Longleng had, vide letter No.RD/LLG/RTI/2021-22 dated 20/07/2022 submitted to the Joint Director, RD Blocks, Nagaland, Kohima instead of the applicant, the RTI reply under PMAY-G scheme, and also stated that the department has not received any fund under Swatch Bharat Mission.

AND WHEREAS, the RTI application was received by the Public Authority on *02.06.2022* as evidenced on the body of the application, however on not getting any information from the PIO, RD, Longleng to his RTI application, the applicant had submitted first appeal dated 06.07.2022 which was received by the Public Authority on the same date i.e *06/07/2022*.

AND WHEREAS, on receipt of the first appeal, Smti. Liboni Humtsoe, Director & FAA had, vide letter *No.DRD/ME/RTI-AA-11/2021-22* dated *26/07/2022* notified for a hearing of both the parties on 03/08/2022 at 01:30 P.M at Directorate of Rural Development. After hearing both the parties, Smti. Liboni Humtsoe, Director & FAA had, vide No.DRD/ME/RTI-AA-11/2021-22 dated *05/08/2022* passed decision stating that on receipt of the RTI application on *02.06.2022*, the PIO & PD, DRDA, Longleng had forwarded to the Office of the BDO on *06.06.2022*, however while compiling the information from the Blocks, delay was occurred due to the ill-health of one of the Block Officers. Further, the PIO was directed to furnish the required information from the date of issue of this Hearing Decision i.e on or before *10/08/2022*.

AND WHEREAS, in compliance to the FAA's decision dated *05/08/2022*, Shri. Moakaba, Project Director & PIO, DRDA Longleng had, vide **No.DRDA/LLG/PMAYG-1/2019-20** dated *05/08/2022* submitted to the Director & FAA the details of FTO generation under PMAYG 1<sup>st</sup> Instalment during 2020-21 pertaining to 2019-20 in respect of RD Block Longleng along with soft copy. He further informed that, pertaining to Query No.6 of the RTI sought, no funds have been received.

AND WHEREAS, on not being satisfied with the information provided by the PIO, after the first appeal hearing, the applicant (now appellant) had filed Second Appeal dated **04.11.2022** to the Nagaland Information Commission.

AND WHEREAS, since the applicant (now appellant) is not satisfied with the information furnished by the PIO even after the first appeal decision, the Commission has decided to hear the above mentioned appeal giving opportunity of being heard to all the parties on 23<sup>rd</sup> November, 2022 (Wednesday) at 01:00 P.M in the Hearing Room of Nagaland Information Commission, Agrifarm Colony, Lane-6, H/No. AFC/578, Nagaland, Kohima.
