WHEREAS, the Commission had on 04.08.2022 at 11.30 A.M. heard the Appeal dated 29.04.2021 (received on the same date) submitted by Shri. Bokuto Swu, Advocate, C/o Tovi Swu, Town Middle School, Half Nagarjan, Dimapur, Nagaland, M/No. 6009135402 / 8132039504 against unsatisfactory information furnished even after the First Appeal hearing of the FAA to his Appeal dated 25.02.2021 which was submitted against non-response of the PIO, Office of the Chief Engineer, Public Health Engineering Department, Nagaland, Kohima to his RTI application dated 22.01.2021.
