**Subject: Closing Order of Appeal Case.**

WHEREAS, the Commission had on **19.10.2022** at **12.30 P.M.** heard the Appeal dated **29.08.2022** (*received on the same date*) submitted by Shri. Toito Sumi, *M/No. 8837374545* and Shri. Kahovi Rochill, *M/No. 7005326368* against non-satisfactory decision of the FAA, Directorate of Social Welfare, Nagaland to their First Appeal dated **28.06.2022** which was submitted against the incomplete information furnished by the PIO to their RTI application dated **NIL**.
