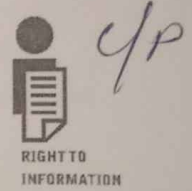

**Subject: Closing Order of Appeal Case.**

WHEREAS, the Commission had on **23.11.2022** at **01.00 P.M.** heard the Second Appeal dated **04.11.2022** (*received on the same date*) submitted by Shri. Imkongchingba Phom, Longleng – 798625, Nagaland, M/No. 8787449263 / 8416043504 against incomplete information furnished even after the First Appeal hearing of the FAA to his Appeal dated **06.07.2022** by the Director & FAA, Directorate of Rural Development, Nagaland, Kohima which was submitted against non-furnishing of information by the PIO, DRDA, Longleng to his RTI application dated **NIL** (*received on 02.06.2022*).

2. AND WHEREAS, after the hearing held on **23.11.2022** at **01.00 P.M.**, the Commission had passed decision vide of even No. dated **30.11.2022**.

3. AND WHEREAS, the applicant (now appellant) had vide letter dated **09.12.2022** (*received on the same date*) submitted non-satisfactory report to the Commission stating that he was not satisfied, as the queries were not addressed or replied as sought.

4. AND WHEREAS, in reference to the above mentioned letter dated **09.12.2022**, the Commission had informed the applicant (now appellant) that, since, during the hearing held on **23.11.2022** at **01.00 P.M.**, his authorized representative, Shri. Bendang, Advocate had expressed satisfaction with all the information so furnished except **Query No. 3** of the RTI application dated **NIL**, the Commission had vide letter of even No. dated **19.12.2022** dismissed the letter dated **09.12.2022** and reiterated its stand on the decision of even No. dated **30.11.2022**.

5. AND WHEREAS, in compliance to the **Point No. 1** of the above mentioned decision, Shri. Moakaba, Project Director & PIO, DRDA, Longleng, Nagaland had, vide letter **No. DRDA/LLG/RTI-1/2022-23** dated **12.12.2022** furnished the explanation in regard to **query No. 3** of the RTI application to the applicant (now appellant) and with a copy to this Commission.

6. AND WHEREAS, referring to **Point No. 2** of the decision of the Commission of even No. dated **30.11.2022**, no confirmation regarding satisfaction/non-satisfaction of the written explanation furnished by the PIO for **query No. 3** has been received even after the lapse of **15 (fifteen) days** from the date of receipt of the information, suggesting that the applicant (now appellant) was satisfied with the explanation.

7. AND WHEREAS, in compliance to the **Point No. 3** of the above mentioned decision, Smti. Liboni Humtsoe, Director & FAA, Rural Development, Nagaland, Kohima had, vide letter **NO.DRD/RTI-AA-11/2021-2022** dated **21.12.2022** forwarded to this Commission the Treasury Challan (*in original*) bearing Challan **No. 17** dated **21.12.2022** for the penalty amount of **Rs. 8,000/-** deposited by Shri. Moakaba, Project Director & PIO, DRDA, Longleng, Nagaland which was imposed on him for contributing to the delay in furnishing the information to the applicant (now appellant).

8. AND WHEREAS, since all the compliances to the decision of the Commission of even No. dated **30.11.2022** have been received, the Commission has now decided to close the Appeal case.

9. NOW THEREFORE, it is notified to all the parties that this Appeal case is hereby declared as closed.


