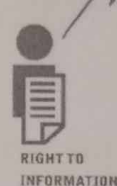

**Subject: Closing Order of Appeal Case.**

WHEREAS the Nagaland Information Commission had heard the Second Appeal dated **21.11.2022** (received on the same date) on **20.01.2023 at 11.30 A.M** submitted by Shri. Kedou Wetsah, Co-Chairman, PGD, NPCC, Congress Bhavan, Nagaland, Kohima-797001, *M/No. 9436001640* and Shri. Imkongmeren Jamir, Member, PGD, NPCC, *M/No. 9436005187* against the unsatisfactory response of the FAA, Directorate of Tribal Affairs, Nagaland to their First Appeal dated **13.10.2022** which was submitted against the non-response of the PIO to their RTI application dated **01.09.2022**.

2. AND WHEREAS, after the second hearing held on **20.01.2023 at 11.30 A.M**, the Commission had passed decision vide even No. dated **30.01.2023**.

3. AND WHEREAS, in compliance to the **Point No. 1** of the Commission's decision of even No. dated **30.01.2023**, Shri. Imsumeren, Project Officer- cum- Nodal officer for PMMAGY Scheme, Directorate of Tribal Affairs, Nagaland, Kohima had, vide letter **No.DTAN/MISC/RTI/7/2021** dated **07.02.2023** re-furnished the information pertaining to **queries No. 3, 5, 6, 7, 8, 9, 10 & 11** to the applicants (now appellants) and with a copy to this Commission.

4. AND WHEREAS, in compliance to the **Point No. 2** of the above mentioned decision the applicants (now appellants) had submitted their satisfaction to this Commission vide letter **No.NPCC/PGD-1/2022-23/55** dated **22.03.2023** of the information so furnished by the PIO.

5. AND WHEREAS, in compliance to the **Point No. 3** of the above mentioned decision, Shri. Imsumeren, Project Officer- cum- Nodal officer for PMMAGY Scheme, Directorate of Tribal Affairs, Nagaland, Kohima had, vide letter **No. DTAN/MISC/RTI/7/2021** dated **07.02.2023** submitted to the Commission the Treasury Challan (*in original*) bearing Challan No. **No. 12** dated **06.02.2023** for a penalty amount of **Rs. 3250/-** which was imposed on him for contributing to the delay in furnishing the information to the applicants (now appellants).

6. AND WHEREAS, since the Commission had received all the compliances to its decision of even No. dated **30.01.2023**, the Commission has now decided to close the Appeal case.

7. NOW THEREFORE, it is notified to all the parties that this Appeal case is hereby declared as **closed**.


