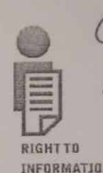

Subject: Closing Order of Appeal Case.

WHEREAS, the Commission had on 22.04.2021 at 12.00 P.M heard the Second Appeal dated 01.06.2020 (received on 02.06.2020) submitted by Shri. Lhousito Khro, President, NTUCT, Chumoukedima Town, Ward-2, M/No. 7628086245 / 8837348261 against the non-satisfactory response of the FAA to his First Appeal NO. NTUCT/RTI-PHQ/AP-05-2020 dated 13.05.2020 which was submitted against the non-response of the PIO to his RTI application dated 03.03.2020.

2. AND WHEREAS, after the hearing held on 22.04.2021 at 12.00 P.M., the Commission had passed its decision vide even No. dated 27.07.2021.

3. AND WHEREAS, in response to the above mentioned decision, Shri. T. John Longkumer, IPS, DGP, Nagaland & FAA had, vide letter NO. PHQ(CON-II)185/RTI/2015-16/2516 dated 06.09.2021 denied to provide information citing various reasons.

4. AND WHEREAS, in reference to the above letter submitted by the FAA, the Commission had vide letter of even No. dated 24.11.2021 reiterated its decision of even No. dated 27.07.2021 and directed the FAA to furnish the information as sought by the applicant (now appellant) within 2 (two) weeks from the date of receipt of the directive.

5. AND WHEREAS, Shri. Joseph Hesso, IPS, Dy. IGP (Hqr.), Nagaland had vide letter NO.PHQ(CON-III185/RTI/2015-16/PART-I/1372 dated 06.12.2021 preferred to Shri. T. B. Jamir, Sr. Addl. Advocate General, Gauhati High Court Kohima Bench to appeal against Order No. NIC/Appeal-1/2020-21 dated 24.11.2021 with a copy to this Commission.

6. AND WHEREAS, the applicant (now appellant) had vide letter dated 13.12.2021 submitted to the Commission stating that the PIO had not furnished the information in compliance to the Commission's directive of even No. dated 24.11.2021.

7. AND WHEREAS, in reference to the above mentioned PHQ letter dated 06.12.2021, the Commission had vide letter of even No. dated 17.12.2021 reminded the DGP & FAA, PHQ, Nagaland to furnish the information without further delay.

8. AND WHEREAS, in response to this Commission's letter of even No. dated 17.12.2021, Shri. S. Tokiumong Yim, IPS, IGP (Hqr) & PIO, PHQ, Nagaland had vide letter NO.PHQ(CON-III185/RTI/2015-16/PART-I/1619 dated 18.12.2021 informed the Commission that the matter is preferred in the Court.

9. AND WHEREAS, the Gauhati High Court Kohima Bench had vide Case No. WP(C) 142/2020 order dated 28.11.2022 disposed off the case as infructuous.

10. AND WHEREAS, in pursuance to the above mentioned Hon'ble High Court order dated 28.11.2022, the Commission had vide letter of even No. dated 21.02.2023 directed the PIO, PHQ to furnish the information to the applicant (now appellant) within 15 (fifteen) days.

11. AND WHEREAS, in response to the Commission's letter of even No. dated 21.02.2023, Shri. Joseph Hesso, IPS, IGP (HQ) & PIO, PHQ, Nagaland had vide letter NO.PHQ/RTI/GEN/2020/2924 dated 28.02.2023 submitted that the matter in WP(C)142/2020 has become infructuous and accordingly the Hon'ble Court has disposed off the case as infructuous and no further directive to furnish any document was issued.

12. AND WHEREAS, the Commission agrees with the proposition submitted by the PIO, it is decided to close the case.

13. NOW THEREFORE, it is notified to all the parties that this Appeal case is hereby declared as closed.


