Subject: Closing Order of Appeal Case.

WHEREAS, the Commission had on **24.11.2022 at 11.30 A.M.** heard the Complaint dated **07.11.2022** (received on the same date) submitted by Shri. R. N. Nungsang, Mokokchung, M/No. 8787383336 / 9402724048 against non-furnishing of information by the PIO, Directorate of Urban Development, Nagaland, Kohima to his RTI application dated **26.04.2022**.

2. AND WHEREAS, after the hearing held on **24.11.2022 at 11.30 A.M.**, the Commission had passed decision vide even No. dated **29.11.2022**.

3. AND WHEREAS, in compliance to the **Point No. 1** of the above mentioned decision, Er. Ketouzo Peseyie, Executive Engineer-I & PIO, Urban Engineering Wing, Kohima, Nagaland had, vide letter **No.EE/UDD/RTI/2021-22/Pt/216** dated **09.12.2022** furnished the complete information free of cost to the applicants (now appellants) and with a copy to this Commission.

AND WHEREAS, regarding **Point No. 2** of the above decision, since the Commission had not received any confirmation for satisfaction or non-satisfaction of the information so furnished to him by the PIO, within the time frame of **15 (fifteen) days** given by the Commission, as per the above decision, it is presumed that the applicant (now complainant) is satisfied and, hence decided to declare the complaint case as closed.

5. AND WHEREAS, in compliance to the **Point No. 3** of the above mentioned decision, Er. Ketouzo Peseyie, Executive Engineer-I & PIO, Urban Engineering Wing, Kohima, Nagaland had, vide letter **No.EE/UDD/RTI/2021-22/Pt/217** dated **09.12.2022** forwarded the Treasury Challan **No. 2** dated **08.12.2022 (In original)** for an amount of **₹ 25,000/-** on account of penalty imposed for contributing to the delay in furnishing the information to the applicant (now complainant).
