Subject: Closing Order of Appeal Case.

WHEREAS, the Commission had heard the Second Appeal dated **27.10.2022** (*received on the same date*) for the second time on **15.03.2023** at **11.30 A.M.** which was submitted by Shri. Roka Swu *M/No. 9366071145* and Shri. Cheno, *M/No. 8729993031*.

2. AND WHEREAS, after the second hearing held on **15.03.2023** at **11.30 A.M.**, the Commission had passed decision vide even No. dated **20.03.2023**.

3. AND WHEREAS, in compliance to the Point No. 2 of the above mentioned decision, Shri. Lhouchalie Viya, IAS, Commissioner & Secretary, NSDMA, Home Department, Nagaland, Kohima (the then Secretary & PIO, NSDMA, Home Department) had vide letter **NO.NSDMA/RTI/274/2019 (Pt.)/401** dated **19.04.2023** submitted to the Commission, the Treasury Challan (*in original*) bearing Challan No. 8 dated **17.04.2023** for the penalty amount of **Rs. 1,250/-** (*Rupees one thousand two hundred fifty only*) which was imposed on him for contributing to the delay in furnishing the information to the applicants (now appellants).

AND WHEREAS, in compliance to the Point No. 3 of the above mentioned decision, the Public Authority i.e. the NSDMA, Home Department, Nagaland, Kohima had reviewed its Notification dated **28.10.2022** and issued the updated Notification vide **NO.NSDMA/RTI/274/2019/387** dated **18.04.2023** and with a copy endorsed to the Commission.

AND WHEREAS, referring to the Point No. 1 of the decision of the Commission since sufficient time has lapsed and there was no response from the applicants (now appellants), suggesting that the applicants (now appellants) were satisfied with the information and have no further interest in their RTI case, the Commission has decided to declare the appeal as closed.

6. NOW THEREFORE, it is notified to all the parties that this Appeal case is hereby declared as **closed.**
