Gupta, H/No. 238, Lhomithi Colony, Dimapur, Nagaland, M/No. 9436832498 against the non-response of the FAA, O/o the Deputy Commissioner, Dimapur, Nagaland to 2(two) Nos. of First Appeals dated **09.11.2022** which were submitted against the non-response of the PIO, O/o the Deputy Commissioner, Dimapur, Nagaland to his RTI applications dated **29.09.2022** and **03.10.2022**.

2. AND WHEREAS, after the hearing held on **20.03.2023** at **11.30 A.M.**, the Commission had passed decision vide even No. dated **23.03.2023**.


