**Subject: Closing Order of Complaint Case.**

WHEREAS, the Nagaland Information Commission had, on 13/04/2022 received a Complaint dated 11/04/2022 from 1. Moses Rose, 2. Vizovolie Nyekha (Butu), 3. Vekrohu Ngoi, 4. Ruyosuyi Khusoh, 5. Thujonuyi Keyho, 6. Bilhunyi Nyekha, 7. Veku Sapu, 8. Veto Keyho, 9. Vetolilu Vetaho, 10. Vethitso Ringa, 11. Nesanyi Nyekha, 12. Theyehuyi Dawhuo, 13. Hurhayi Theyo, 14. Kehuthita Thisa, 15. Veseta Swuro, 16. Vedutso Swiho, 17. Besukhoyi Kezo, 18. Nerhisayi Resu, 19. Kethonu Swuro, 20. Huta Resu, 21. Besusayi Nyekha, 22. Vezokho Nyekha, 23. Chizonyi Khusoh, 24. Chekroduyi Theyo, 25. Vekhole Rhakho and 26. Huppaneyi Dawhuo, C/O. Neiteo Koza, Advocate, Ladies Bar Room, Gauhati High Court, Kohima Bench, Old Ministers' Hill, Kohima, Nagaland, Mobile No- 7005134951 for refusing to furnish information to their RTI application dated 28/02/2022 by the PIO, Office of the Lokayukta, Nagaland, Kohima.

AND WHEREAS, the applicants had jointly submitted an RTI application dated 28/02/2022 along with Rs. 10/- as application fee, seeking certified true copy of the following information in relation to the Notice for appearance issued to 1. Shri. Chizonyi Khusoh, 2. Chozuba Town, Shri. Veku Khusoh, Chozuba Town, & 25 Others:-

- 1) Kindly furnish copy of the counter case/ Complaint filed against the complainant Chizonyi Khusho and list of witnesses in RC 3/2020 2 Lane Chakhabama- Zunheboto Road compensation case.
- 2) Furnish information on what ground the complaint was received and registered. Furnish all supporting documents/ annexures attached to the said complaint letter as proof of evidence to their complaint in true photocopies.
- 3) Provide information on the status off the preliminary investigation undertaken on the counter case/ complaint filed against Chizonyi Khushoh and list of 26 witnesses in the case mentioned in point No. 1 above.
- 4) Kindly furnish copy of the specific Order issued by your Office for withholding the payment of damage compensation of the complainant and 26 witnesses in RC3/2020 case. Also mention the ground for withholding their damage compensation.
- 5) Furnish information whether your payment withholding order vide letter No.R.C 03/2020 dated Kohima the 11<sup>th</sup> March 2021. Justify and furnish reasons if the said order is still in force, why was damage compensation paid to some property owners on 12<sup>th</sup> March 2021 and also a group of property owners in the month of December 2021 against the stay order.

AND WHEREAS, on receipt of the RTI application dated 28/02/2022 on 03/03/2022, Smti. Vikono Peseyie, Superintendent of Police & PIO, Nagaland Lokayukta Police, Nagaland, Kohima had, vide letter NO. NLP/RTI/PIO-2/2021 dated 19/03/2022 wrote to the applicants that since the matter was under investigation by the Nagaland Lokayukta Police, it was regretted to inform that the information sought could not be furnished.

AND WHEREAS, on not being satisfied with the reply of the PIO, the applicants had submitted Complaint dated 11/04/2022 to the Nagaland Information Commission.

AND WHEREAS, on receipt of the complaint, the Commission had, vide letter NO. NIC/Gen/RTI-19/17 dated 20/04/2022 directed the PIO to furnish the information which are not exempted and also submit the reason for inability to furnish the others queries sought by the applicants (now complainants) to this Commission within 2(two) weeks from the date of receipt of its directive for further necessary action.

AND WHEREAS, on receipt of the above Commission's directive, Smti. Vikono Peseyie, Superintendent of Police & PIO, Nagaland Lokayukta Police, Nagaland, Kohima had, vide letter **NO. NLP/RTI/PIO-2/2021 dated 29/04/2022** furnished the information to the applicants (now complainants) and with a copy to the Commission.

AND WHEREAS, on receipt of the information furnished by the PIO, the Commission had, vide letter **NO. NIC/Gen/RTI-19/17 dated 12/05/2022** requested the applicants (now Complainants) to confirm satisfaction/ non-satisfaction to the PIO and with a copy to the Nagaland Information Commission for further necessary action.

AND WHEREAS, on not receiving any response from the applicants (now Complainants) regarding their satisfaction/ non-satisfaction with the information furnished by the PIO, the Commission had again vide letter **NO. NIC/Gen/RTI-19/17 dated 22/09/2022** directed the applicants (now Complainants) to confirm satisfaction/ non-satisfaction **within 10 (ten) days**. In case, no confirmation is received within the time frame given by the Commission, the case shall be presumed as satisfied and the case shall be closed and no further request to re-open the case shall be entertained.

AND WHEREAS, in compliance to the directives of the Nagaland Information Commission, the applicants (now Complainants) had, vide letter dated **20/09/2022** submitted to the PIO, Nagaland Lokayukta Police and with a copy to the Commission that the RTI reply dated **29/04/2022** given by the PIO was received and satisfied.

AND WHEREAS, since the applicants (now complainants) had received and are satisfied with the information furnished by the PIO, the Nagaland Information Commission decided to close the case.

NOW THEREFORE, it is notified to the following parties that the Complaint case is hereby declared as **closed**:-
