Subject: Closing Order of Appeal Case.

WHEREAS, under Section 19 of the RTI Act, 2005 and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Commission had on 19.01.2023 at 12.00 Noon and 15.03.2023 at 12.00 Noon heard the Second Appeal dated 18.11.2022 submitted by Shri. Honoto I. Yeptho, M/No. 8575387880 and Shri. Ikato Sumi, M/No. 8794230133 against the unsatisfactory information furnished by the FAA, NSDMA to their First Appeal dated 07.06.2022 which was submitted against the unsatisfactory response of the PIO to their RTI application dated NIL.

- 2. AND WHEREAS, after the hearings held on 19.01.2023 at 12.00 Noon and 15.03.2023 at 12.00 Noon, the Commission had passed decisions of even No. dated 20.01.2023 and 20.03.2023 respectively.
- 3. AND WHEREAS, after the second hearing held on 15.03.2023 at 12.00 Noon, the Commission had passed decision of even No. dated 20.03.2023 wherein, the Commission had decided that the PIO shall explain or clarify to the applicants (now appellants) the anomalies and discrepancies pointed out by them within the month of March, 2023. Thereafter, the applicants (now appellants) shall submit satisfaction or non-satisfaction to the PIO and with a copy to the Commission within 15 (fifteen) days from the date of receipt of the information. In case, no confirmation is received from the applicant (now appellant) within the time frame given by the Commission, the case shall be presumed as satisfied and no further request to re-open the case shall be entertained.
- 4. AND WHEREAS, in reference to the above mentioned decision, Shri. Lhouchalie Viya, IAS, Commissioner & Secretary, NSDMA, Home Department, Nagaland, Kohima had, vide letter *No.NSDMA/RTI/274-1000/2019/301* dated *29.03.2023* and with a copy to this Commission intimated the applicants (now appellants) to present themselves at the NSDMA Secretariat on 30th March, 2023 or 31st March, 2023 during working hours to clarify their doubts.
- 5. AND WHEREAS, in reference to the above mentioned letter dated 29.03.2023, the Commission had vide letter of even No. dated 30.06.2023 directed Shri. Lhouchalie Viya, IAS, Commissioner & Secretary, NSDMA, Home Department, Nagaland, Kohima to submit the proof of receipt of the above mentioned letter dated 29.03.2023 by the applicants (now appellants) and also to ascertain if they had actually visited the NSDMA Secretariat office to clarify the anomalies and discrepancies pointed out by them and are satisfied.
- 6. AND WHEREAS, on not getting any no response to the above mentioned letter dated 30.06.2023, the Commission had vide letter of even No. dated 08.08.2023 issued a reminder to Shri. Lhouchalie Viya, IAS, Commissioner & Secretary, NSDMA, Home Department, Nagaland, Kohima to inform the Commission on the compliance to the above mentioned directive dated 30.06.2023.

- AND WHEREAS, in reference to the above mentioned Commission's letter dated 30.06.2023 and reminder letter dated 08.08.2023, Shri. Lhouchalie Viya, IAS, Commissioner & Kohima had, NSDMA, Home Department, Nagaland, No.NSDMA/RTI/274-1000/2019/999 dated 10.08.2023 submitted to the Commission stating that a meeting was held with the applicants (now appellants) on 31.03 2023 and subsequently had received a letter of satisfaction dated NIL from the applicants (now appellants) on 05.06.2023 and had enclosed a copy of the satisfaction letter.
- AND WHEREAS, since all the compliance to the of the Commission's decision of even 8. No. dated 20.03.2023 had been received, the Commission has decided to declare the appeal as closed.
- NOW THEREFORE, it is notified to all the parties that this Appeal case is hereby 9. declared as closed.
