Subject: Closing Order of Appeal Case.

WHEREAS, the Commission had on 17.03.2023 at 12.00 Noon heard the Second Appeal dated 03.02.2023 (received on the same day) submitted by Shri. Inagha Sumi, Dimapur, M/No. 8974446447 against non-response of the FAA, Planning & Coordination Department, Nagaland to his First Appeal dated 25.02.2021 which was submitted against unsatisfactory reply of the APIO to his RTI application dated 12.09.2022.

- AND WHEREAS, after the hearing held on 17.03.2023 at 12.00 Noon, the Commission had passed decision vide of even No. dated 28.03.2023.
- AND WHEREAS, in compliance to the Point No. 1 of the above mentioned decision, Shri. N. Nlumo Murry, Deputy Development Commissioner & FAA, Planning & Coordination Department, Nagaland had, vide letter No. PLN/M-591/22 (Pt)/815 dated 10.04.2023 (signed on 11.04.2023) furnished the information to the applicant (now appellant) with a copy to this Commission.
- AND WHEREAS, in reference to Point No. 2 of the above decision of the Commission, 4. the applicant (now appellant) had, vide letter dated 24.04.2023 submitted his non-satisfaction report to this Commission stating that the following points are yet to be clarified by the department;

1. SDF, 2020 - the documents amounting to Rs. 20 lakhs is yet to be furnished.

- 2. SDF, 2019 the Utilization documents of the Chief Secretary Office, amounting to Rs. 20 lakhs and the Development Commissioner Office amounting to Rs. 20 lakhs are yet to be furnished.
- 3. No official letter counter signed by the highest authority of the department stating that there is no aims and objective of the SDF since it is a financial assistance.
- 4. Not furnished / mentioned in which year the implementation of SDF was started.
- 5. If the concerned department is of the view that fund were utilized without accountability then kindly substantiate the same in writing owning the responsibility by the implementing and disbursal authority.
- AND WHEREAS, on receipt of the above letter dated 24.04.2023, the Commission had vide letter of even No. dated 17.05.2023 directed the Deputy Development Commissioner & FAA to furnish the complete and correct information to the applicant (now appellant) and with a copy to the Commission within 15 (fifteen) days from the date of receipt of the directive.
- AND WHEREAS, since there was no response from the FAA, the Commission had vide letter of even No. dated 21.07.2023 issued a reminder directing the Deputy Development Commissioner & FAA to furnish the complete information to the applicant (now appellant) and with a copy to the Commission within 15 (fifteen) days from the date of receipt of the directive.
- AND WHEREAS, in compliance to this Commission's letters of even No. dated 17.05.2023 & 21.07.2023. Shri. N. Nlumo Murry. Deputy Development Commissioner & FAA.

- AND WHEREAS, in reference to Point No. 2 of the above decision of the Commission, though sufficient time has lapsed since there has been no response from the applicant (now appellant) till date suggesting that he is satisfied with the information and has no longer interest to pursue his appeal, the Commission has decided to close the appeal case.
- 9. AND WHEREAS, in reference to *Point No. 3* of the above decision of the Commission, the public authority had, vide No. PLN/M-591/22 (Pt) dated 18.05.2023 informed that the Commission's recommendation to come out with aims, objectives and/or guidelines for proper implementation of any Schemes, plans, programmes or projects in future is under process.
- AND WHEREAS, since all the compliances to the decision of the Commission of even No. dated 28.03.2023 have been received, the Commission has now decided to close the Appeal case.

NOW THEREFORE, it is notified to all the parties that this Appeal case is hereby declared as closed.
