**Subject: Closing Order of Complaint Case.**

WHEREAS, the Commission had on **04.05.2023** at **11.00 A.M.** heard the Complaint dated **10.04.2023** (received on the same date) submitted by Shri. Vimeyiel Richa, C/o NEDFI Office, Kohima Branch, P.R. Hill, Kohima- 797001, Nagaland, M/No. 9856092133, Email – [v.richa@nedfi.com](mailto:v.richa@nedfi.com) against incomplete /incorrect information furnished by the PIO, Directorate of Animal Husbandry & Veterinary Services, Nagaland, Kohima in reply to his RTI application dated **23.01.2023**.

2. AND WHEREAS, after the hearing held on **04.05.2023** at **11.00 A.M.**, the Commission had passed decision vide even No. dated **15.05.2023**.

3. AND WHEREAS, since the Commission did not receive any compliance to its decision dated 15.05.2023, the Commission had, vide letter of even No. dated **28.07.2023** reminded Dr. Achila Ao, Additional Director, Directorate of A.H & VS, Nagaland, Kohima and Dr. Khrieketoulie Linyu, Additional Director, Directorate of A.H & VS, Nagaland, Kohima to comply to the decision of the Commission.

4. AND WHEREAS, in compliance to the above mentioned decision **15.05.2023** & directive dated **28.07.2023**, Dr. Khrieketoulie Linyu, Additional Director, Directorate of A.H & VS, Nagaland, Kohima had, vide letter dated **02.08.2023** submitted to the Commission the Treasury Challan (in original) bearing Challan No. 2 dated **31.05.2023** for the penalty amount of **Rs. 1,500/- (Rupees one thousand five hundred only)** which was imposed on him for contributing to the delay in furnishing the information to the applicant (now complainant).

5. AND WHEREAS, in compliance to the above decision of the Commission dated **15.05.2023** & directive dated **28.07.2023**, Dr. Achila Ao, Additional Director, Directorate of A.H & VS, Nagaland, Kohima had also, vide letter dated **04.04.2023** submitted to the Commission the Treasury Challan (in original) bearing Challan No. 1 dated **31.05.2023** for the penalty amount of **Rs. 5750/- (Rupees five thousand seven hundred fifty only)** which was imposed on her for contributing to the delay in furnishing the information to the applicant (now complainant).

6. AND WHEREAS, since all the compliances to the decision of the Commission of even No. dated **15.05.2023** have been received and that as observed during the hearing on **04.05.2023**, the applicant (now complainant) had expressed his satisfaction with the information so furnished to him on the date of hearing, the Commission has now decided to close the Complaint case.

NOW THEREFORE, it is notified to all the parties that this Complaint case is hereby declared as closed.


