Rahul Bhanudas Mali, IAS, Deputy Commissioner & FAA, Office of the Deputy Commissioner, Zunheboto, Nagaland had, vide letter No.DCZ/RTI/2023/304 dated 17/11/2023 reiterated the earlier reply of the PIO that the information sought could not be disclosed under section 8 (a), (g) & (j) of the RTI, Act 2005 in view of the sensitive nature of the case.

AND WHEREAS, on being denied information by the FAA and the PIO, the applicants (now appellants) had submitted a second appeal dated 20/11/2023 to the Nagaland Information Commission.

AND WHEREAS, since the applicants(now appellants) were denied information by invoking section 8 (a), (g) & (j) of the RTI, Act 2005 by the FAA and the PIO, the Commission has decided to hear the above mentioned appealby giving opportunity of being heard to all the parties on 18<sup>th</sup>January, 2024 (Thursday) at 11:30 A.M in the Hearing Room of Nagaland Information Commission, Nagaland Commissions' Complex, Below NBCC Convention Centre, Nagaland, Kohima.
