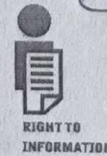

**Subject: Closing Order of Appeal Case.**


