**Subject: Closing Order of Appeal Case.**

WHEREAS, under Section 19 of the RTI Act, 2005 and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Commission had on **22.08.2023** at **11.00 AM** heard the Second Appeal dated **NIL** (received on 18.07.2023) submitted by Shri. Inato & Associates, Social Activist, M/No. 9863302011 / 7005960261 against the unsatisfactory response of the FAA to their First Appeal dated **NIL** (received on 16.03.2023) which was submitted against the non-response of the PIO to their RTI application dated **NIL** (received on 06.02.2023).

2. AND WHEREAS, after the hearing held on **22.08.2023** at **11.00 AM**, the Commission had passed decision of even No. dated **25.08.2023**.

3. AND WHEREAS, in reference to the **Point No. 1** of the above mentioned decision, Shri. Temsuwangshi Jamir, Assistant Manager & PIO, NSDMA, Home Department, Nagaland, Kohima had, vide letter No. **NSDMA/RTI/274-1013/2019/1165** dated **25.09.2023** requested the Commission for extension of timeframe till **31.10.2023** in view of the Departmental Compliance Audit which was still ongoing where all their resources are engaged for the audit.

4. AND WHEREAS, in reference to the above mentioned letter of the PIO, the Commission had, vide letter of even No. dated **09.10.2023** allowed for extension of **15 (fifteen) days** for compliance to the **Point No. 1** of the Commission's decision.

5. AND WHEREAS, in compliance to the **Point No. 1** of the above mentioned decision and Commission's letter of even No. dated **09.10.2023**, Shri. Temsuwangshi Jamir, Assistant Manager & PIO, NSDMA, Home Department, Nagaland, Kohima had, vide letter No. **NSDMA/RTI/274-1013/2019/1240** dated **18.10.2023** furnished the following information to the applicants (now appellants) with a copy to the Commission:

1. For query No. 2, the list of beneficiaries with only names and amount received by the beneficiary

Reply: - List of beneficiaries is enclosed as Annexure-I.

2. For query No. 3, the Utilization Certificates and Completion Certificates whatever were ready or completed or available.

Reply: - The Utilization Certificate for Drought (kharif and Rabi) of 2021 submitted to the Ministry of Agriculture and Farmer Welfare, Department of Agriculture of Farmers Welfare (Drought Management Division), Govt. of India, is enclosed as Annexure-II

6. AND WHEREAS, in compliance to the **Point No. 2** of the above mentioned decision, Shri. Inato & Associates, the applicants (now appellants) had submitted a letter dated **02.02.2024** to the Nagaland Information Commission stating that they were satisfied with the complete information furnished by the NSDMA vide their letter No. **NSDMA/RTI/274-1013/2019/1240**.

7. AND WHEREAS, in compliance to the Point No. 3 of the above decision of the Commission, Shri. Temsuwangshi Jamir, Assistant Manager & PIO, NSDMA, Home Department, Nagaland, Kohima had, vide letter No. *NSDMA/RTI/274-1013/2019/1121* dated *11.09.2023* submitted to the Commission the Treasury Challan (in original) bearing Challan No. *9* dated *11.9.2023* for the penalty amount of *Rs. 6000/-* which was imposed on him for contributing to the delay in furnishing the information to the applicants (now appellants).

8. AND WHEREAS, since all the compliances to the decision of the Commission of even No. dated *25.08.2023* have been received, the Commission has now decided to close the Appeal case.

9. NOW THEREFORE, it is notified to all the parties that this Appeal case is hereby declared as closed.


