Subject: Closing Order of Appeal Case.

WHEREAS, the Commission had issued closing order of even No. dated **03.04.2023** basing on the submission of the PIO, PHQ vide their letter **NO.PHQ/RTI/GEN/2020/2924** dated **28.02.2023** that the Hon'ble Gauhati High Court had in **WP(c) 142/2020** disposed of the case as "**INFRUCTUOUS**" and no further directive was given to furnish the information.

2. AND WHEREAS, the applicant (now appellant) had, vide letter dated **07.08.2023** submitted to the Commission to rectify the usage of the legal term "**INFRUCTUOUS**" in **WP(c) 142/2020 (Shri. Lhousito Khro – Vrs – State of Nagaland & Ors)** arising out of **NIC/APPEAL-1/2020-21** since the present Court Judgement is linked to another similar case dismissed by the Hon'ble Gauhati High Court in **WP(c) 39/2022 (Shri. T. John Longkumer & Anr – Vrs – NTUCT & Anr)** arising out of **NIC/APPEAL-4/2020-21**.

3. AND WHEREAS, the Commission had on **04.09.2023** issued the Rectification in the usage of the term "**INFRUCTUOUS**" in the closing order dated **03.04.2023** of the Nagaland Information Commission.

4. AND WHEREAS, the Commission had, vide letter of even No. dated **25.10.2023** issued a "**Reminder**" to the PIO, O/o the DGP, PHQ, Nagaland to furnish the complete information to the applicant (now appellant) **within 15 days** from the date of receipt of the reminder and thereafter confirm satisfaction or non-satisfaction of the information so furnished from the applicant (now appellant) under intimation to this Commission.

5. AND WHEREAS, in compliance to the above mentioned letter of the Commission dated **25.10.2023**, Shri. Joseph Hesso, IPS, IGP & PIO, PHQ Nagaland had, vide letter **NO.PHQ (RTI-I) APPEAL-1/2020/993** dated **31.10.2023** furnished the requisite information to the applicant (now appellant) and with a copy to the Commission.

6. AND WHEREAS, since there was no response from the applicant (now appellant) regarding the receipt and satisfaction or non-satisfaction of the information inspite of having furnished by the PIO, PHQ on **31.10.2023** the Commission had, vide letter of even No. dated **14.02.2024** directed the applicant (now appellant) to confirm satisfaction or non-satisfaction of the information so furnished **within 15 days** from the date of receipt of the directive.

7. AND WHEREAS, in compliance to the Commission's directive of even No. dated **14.02.2024**, Shri. Lhousito Khro, the applicant (now appellant) had, vide letter dated **02.05.2024** submitted to the PIO, PHQ, Nagaland and with a copy to this Commission stating that the information was furnished and was satisfactory.

8. AND WHEREAS, since all the compliances to the Commission's order of even No. dated **04.09.2023** have been received, the Commission has decided to close this Appeal case.

9. NOW THEREFORE, it is notified to all the parties that this Appeal case is hereby declared as **closed**.


