Subject: Closing Order of Appeal Case.

WHEREAS, the Commission had heard the Second Appeal dated *NIL* (received on 18.08.2023) on 22.11.2023 at 11.00 A.M. submitted by Shri. Mbailak Pame, Samziuram Village, M/No. 9383089259 / 7085686429 against the non-response of the FAA, Directorate of Food & Civil Supplies, Nagaland, Dimapur to his First Appeal dated *NIL* (received on 12.07.2023), which was submitted against the non-response of the PIO, Food & Civil Supplies, Dimapur to his RTI application dated *NIL* (received on 23.05.2023).

2. AND WHEREAS, after the hearing held on 22.11.2023 at 11.00 A.M., the Commission had passed decision vide even No. dated 23.11.2023.

3. AND WHEREAS, in compliance to the Point No. 1 & 2 of the above mentioned decision dated 23.11.2023, Shri. Neisazo Domeh, Assistant Director, Food & Civil Supplies, Peren had, vide letter No.PR/RTI-1/2021-22/85 dated 31.01.2024 submitted to the Commission, a copy of the information which was given to the applicant (now appellant) and also the Treasury Challan (*in original*) bearing Challan No. 6 dated 08.01.2024 for the penalty amount of Rs. 23,750/- (*Rupees twenty three thousand seven hundred fifty only*) which was imposed on him for contributing to the delay in furnishing the information to the applicant (now appellant).

4. AND WHEREAS, since all the compliances of the above mentioned decision dated 23.11.2023 have been received and that the applicant (now appellant) had expressed his *satisfaction* during the hearing held on 22.11.2023, the Commission has decided to close the Appeal case.


