Subject: Closing Order of Appeal Case.

WHEREAS, under Section 19 of the RTI Act, 2005 and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Commission had on 21.08.2024 at 11.00 A.M. and 04.10.2024 at 11.00 A.M. heard the Second Appeal dated NIL submitted by Shri. Hanso Chang, Lerie Colony, Kohima, M/No. 8787815876 against the unsatisfactory information furnished by the PIO, Directorate of School Education to his RTI application dated 17.10.2023.

- 2. AND WHEREAS, after the hearings held on 21.08.2024 at 11.00 A.M. and 04.10.2024 at 11.00 A.M., the Commission had passed decisions of even No. dated 30.08.2024 and 09.10.2024 respectively.
- 3. AND WHEREAS, in compliance to the Point No. 1 & 2 of the Order of the Commission dated 09.10.2024, Shri. Razouseyi Vese, Addl. Director, School Education & PIO had, vide letter NO. ED/RTI/MISC-2/2017 dated 24.10.2024 forwarded the Medical Certificate dated 03.10.2024 in r/o Er. Hokato Sema, Executive Engineer, PWD (H) Education, Kohima, Nagaland and also the Treasury Challan (in original) bearing Challan No. 8 dated 21.10.2024 for the penalty amount of Rs. 22,500/- (Rupees twenty two thousand five hundred) only which was imposed on him for contributing to the delay in furnishing the information to the applicant (now appellant).
- 8. AND WHEREAS, since all the compliances to the Commission's decision of even No. dated 09.10.2024 have been received, the Commission has decided to declare the appeal as closed.
- 9. NOW THEREFORE, it is notified to all the parties that this Appeal case is hereby declared as <u>closed</u>.
