AND WHEREAS, the applicant had submitted an RTI application dated 20.02.2024 along with application fee of Rs. 10/- to the PIO, O/o the Deputy Commissioner, Dimapur, Nagaland seeking the following information: -

- 1. That sir, on dated 27/06/2018 in the Local Daily Newspaper Eastern Mirror, the former Deputy Commissioner, Dimapur, Shri. Sushil Kumar Patel, IAS has directed the Court, in the ninth para of the local daily. Hence you are requested to furnish me the said directed copy letter dated 12/04/2018.
- 2. That sir, The Eviction Order No. 20/2008-D/1173-78 Dated 20/05/2009, the Patta No. 1097 at patta serial No.4 of the eviction order has Dag No. 1/237 and the LRSO'S survey report No. LRSO/D/TECH-2003-04/155 dated 13/03/2009 at Sl. No.3 has the same Dag No. basing on which the wrong implication of eviction law was served. But in the sixth para of the Local Daily stated the Dag No. 11/237. Hence you are requested to furnish me the modification order copy of change of Dag No. from 1/237 to 11/237.

AND WHEREAS, on not receiving any response from the PIO to his RTI application, the applicant had submitted a First Appeal dated 01.05.2024 to the FAA, O/o the Deputy Commissioner, Dimapur for necessary action.

AND WHEREAS, Shri. Zakabo V. Rotokha, ADC & PIO, O/o the Deputy Commissioner, Dimapur had, vide letter No. RTI-15/2022-D/9095 dated 28.08.2024, informed the applicant that basing on the hearing order vide No. RTI-15/2022-D/FA676 dated 21.05, 2024, the information regarding Dag No. 1/237 and 11/237 have been forwarded to the District Land Records & Survey Officer, Dimapur for clarification by the Revenue Officer of the Deputy Commissioner's Office vide letter No. DCD/REV-5/RTI/2023-D/1715 dated 15.07.2024.

AND WHEREAS, on not getting any information till date, the applicant (now appellant) had submitted a Second Appeal dated 09.09.2024 to the Commission.
