**Subject: Closing Order of Appeal Case.**

WHEREAS, the Commission had heard the Second Appeal dated **09.09.2024** on **27.11.2024** at **11:00 AM** and on **03/02/2025** at **11:00 AM** submitted by Shri. K. L. Gupta, H/No. 238, Lhomithi Colony, Dimapur, Nagaland, Mobile No. 9436832498 against the non response of the FAA, O/o the Deputy Commissioner, Dimapur, Nagaland to his first appeal dated **01/05/2024** which was submitted against the non-response by the PIO, O/o the Deputy Commissioner, Dimapur, Nagaland to his RTI application dated **20/02/2024**.


