Subject: Closing Order of Appeal Case.

WHEREAS, the Commission had heard the Second Appeal dated 03/06/2024 on **03/02/2025** at **12:00 Noon** submitted by Shri. Tsuknong (Tsuknungtemsu), H/No-182, Lungkongmendam Ward, Tuli Mokokchung, Mobile No- 8118924953 & Shri. Tinuakum, Dilong Ward, Mokokchung, Mobile No- 9077796880 against the unsatisfactory response of the FAA, Directorate of Rural Development, Nagaland to their first appeal dated 14/03/2024 which was submitted against non-response of the PIO, Directorate of Rural Development, Nagaland to their RTI application dated 12/02/2024.

2. AND WHEREAS, after the hearing held on **03/02/2025** at **12:00 Noon**, the Commission had passed decision vide even No. dated **06/02/2025**.

3. AND WHEREAS, in compliance to the **Point No. 1** and Point **No. 2** of the decision of the Commission dated **06/02/2025**, the applicants (now appellants), Shri. Tsuknong (Tsuknungtemsu), H/No-182, Lungkongmendam Ward, Tuli Mokokchung, Mobile No- 8118924953 & Shri. Tinuakum, Dilong Ward, Mokokchung, Mobile No- 9077796880 had, vide letter No. Nil dated 03/03/2025 submitted to the Commission that they have conducted the inspection of records at Tuli and Changtongya Blocks under Mokokchung District on 24/02/2025 and are satisfied with the inspection of the records.

4. AND WHEREAS, in compliance to the **Point No. 3** of the decision of the Commission dated **06/02/2025**, Smti. M. Mongna Konyak, Addl. Director & HOD/FAA, Directorate of Rural Development had, vide letter No.DRD/RTI-AA-12/2022-23 dated 24/02/2025 forwarded the Treasury Challan (in original) bearing Challan No. 18 dated 24/02/2025 for a penalty amount of **Rs. 25,000/- (Rupees twenty five thousand) only** i/r of Shri. Veduzo Sasu, Deputy Director, Directorate of Rural Development which was imposed on him for contributing to the delay in furnishing the information to the applicants (now appellants).

5. AND WHEREAS, since all the compliances to the Commission's decision of even No. 06/02/2025 have been received, the Commission has decided to declare the appeal as closed.


