Subject: Notice for Hearing on 20<sup>th</sup> May, 2025 (Tuesday) at 11:30 AM.

WHEREAS, the Commission had on 17.02.2025 received a Second Appeal dated 27.01.2025 from Shri. K. Arkha Achumi, Old Minister's Hill, Kohima, Nagaland- 797001, Mobile No- 8448912183 against the inaction of the FAA to his First Appeal dated 18.11.2024 which was submitted against the non-furnishing of information by the PIO to his RTI application dated 30.09.2024.

AND WHEREAS, the applicant had submitted an RTI application dated 30.09.2024 addressed to the PIO, Nagaland Police Headquarters, P.R Hill, Nagaland, Kohima- 797001 along with Rs. 10/- as application fee seeking the following information with respect to the Compassionate appointment in the Police Department:-

1. Request for certified true copy of the compassionate appointment list maintained by your department.
2. Request for certified true copy of the list of appointments made by your department under the Compassionate Appointment Scheme w.e.f. 1<sup>st</sup> January, 2015 till date. Kindly bifurcate the information into the following categories.

Name of the person appointed under the scheme	Name and grade of post he/she is appointed	Name of the deceased and relationship with the person appointed	Date of death of the deceased	Date of application submitted by the applicant for compassionate appointment	Year of appointment	Grade	Deceased place of posting before death

3. Request for tentative list of Grade-III and Grade-IV vacant post expected post retirement in 2024-2025.
4. Request for information about the compassionate appointment policy adopted by your department from 2015 to date.
5. Request for list of appointment made in 1988. Please provide the CTC of appointment orders.
6. Request for list of regular employee posted under the Superintendent of Police, Phek in the year 1988.
7. Is the compassionate appointment list maintained as of date of death of the Government employee or as the date when the applicant submits their application for compassionate appointment?

AND WHEREAS, the above RTI application dated 30.09.2024 was received on the same date i.e. 30.09.2024 as evidenced on the body of the application, however, on not getting any information from the PIO within the stipulated time, the applicant had submitted first appeal dated 18/11/2024 to the FAA, Nagaland Police Headquarters, P.R Hill, Nagaland, Kohima-797001.

AND WHEREAS the First Appeal dated 18.11.2024 was received by the Public Authority on the same date i.e. 18.11.2024 as evidenced on the body of the First Appeal, however, on non-response of the FAA, Nagaland Police Headquarters, P.R Hill, Nagaland, Kohima- 797001, the applicant (now appellant) had filed Second Appeal dated 27.01.2025 to the Nagaland Information Commission.

AND WHEREAS, on receipt of the above second appeal dated 27.01.2025, the Commission had, vide letter of even No. dated 21.02.2025, directed the DGP & FAA, Nagaland



Police Headquarters, P.R Hill, Nagaland, Kohima to take up the first appeal by hearing both the parties and pass decision within 20(twenty) days.

AND WHEREAS, in compliance to the Commission's directive of even No. dated 21.02.2025, the DGP & FAA, Nagaland Police Headquarters, P.R Hill, Nagaland, Kohima had after hearing the first appeal on 18.03.2025 passed decision vide No.PHQ/RTI-I/APPEAL/2020/2062 dated 18.03.2025 stating that the applicant did not appear for the hearing in person, however the applicant had submitted a written request for withdrawal of the first appeal citing that he no longer wished to pursue the appeal as the required information had been duly furnished by the PIO on 28.01.2025.

AND WHEREAS, though the Second Appeal dated 27.01.2025 filed by the applicant (now appellant) lies in the Commission, since the Commission has not received any withdrawal letter and was also not convinced with the withdrawal by the applicant(now appellant), the Commission has decided to hear the above mentioned appeal by giving opportunity of being heard to all the parties on 20<sup>th</sup> May, 2025 (Tuesday) at 11:30 AM, in the Hearing Room of the Nagaland Information Commission, Nagaland Commissions' Complex, Below NBCC Convention Centre, Nagaland, Kohima.

NOW THEREFORE, it is notified that the following parties are directed to appear before this Commission and **also to bring the files and relevant documents** in question for scrutiny on the above date and time.


