Subject: - Notice for hearing on 15th April (Tuesday), 2025 at 12:00 Noon.

WHEREAS, the Commission had received a Second Appeal dated **06.03.2025** from Shri. **Haukieteing**, Peren District, Ph. No. 7005946604 against the unsatisfactory response of the PIO, Directorate of Food & Civil Supplies, Nagaland, Dimapur to his RTI application dated **08.10.2024** despite the directive of the Director & FAA, Directorate of Food & Civil Supplies, Nagaland, Dimapur to furnish the complete information which was in response to the First Appeal dated **18.11.2024**.

AND WHEREAS, the applicant had submitted a RTI application dated **08.10.2024** along with an application fee of Rs. 10/- only addressed to the PIO, Directorate of Food & Civil Supplies, Nagaland, Dimapur seeking the following information: -

1. *Kindly provide us the information of the various schemes allotted for Peren district from 2014 till date.*
2. *Kindly provide the photocopy of the beneficiaries list scheme-wise of all the PHH, AAY, APL, BPL, AY and NPHH Schemes of Peren District from 2014 till date.*
3. *Kindly provide the photocopy of payment receipt scheme-wise made to the beneficiaries of all the PHH, AAY, APL, BPL, AY and NPHH Schemes of Peren District from 2014 till date.*
4. *Kindly provide us the information separately of the beneficiaries list with name/ contact/ village list those who pay professional tax or income tax.*
5. *Kindly provide us the photocopy of the allocation order of rice, wheat, sugar and coarse for Peren District from 2014 till date.*
6. *Kindly provide the photocopy/ documents of the rate per kilogram under the allocated schemes which is issued to the beneficiary in peren district and the rate per kilogram under which it is brought from the Government of India and subsidy amount provided per kilogram under the allocated schemes for Peren District.*
7. *Kindly provide us the photocopy of the allocation order of kerosene for Peren District from 2014 till date.*
8. *Kindly provide the photocopy/ documents of the rate per liter under the allocated schemes which is issued to the beneficiary in Peren District and the rate per liter under which it is brought from the Government of India and subsidy amount provided per liter under the allocated schemes for Peren District.*
9. *Kindly provide the photocopy of the utilization certificates for the Peren District under the allocated schemes foodgrain allocation from 2014 till date.*

AND WHEREAS, on receipt of the above RTI application, Smt. **Kenyuhile Tep**, District Civil Supply Officer, Department of Food & Civil Supplies, Peren, Nagaland had, vide letter No. **SPLY/PRN/RTI/2023-24/63** dated **07.11.2024**, informed to the applicant to come and collect the information on payment of Rs. 7,074/- (Rupees seven thousand and seventy four only) being the cost of paper i.e. A4@ Rs.2/- per page during office hours.

AND WHEREAS, the applicant had submitted a First Appeal dated **18.11.2024** addressed to the Director & FAA, Directorate of Food & Civil Supplies, Nagaland, Dimapur stating that the information provided by the District Civil Supply Officer, Peren, Nagaland was incomplete though his queries do not fall within the restrictions of Section 8 & 9 of the RTI Act, 2005. He further alleged that the act of the District Civil Supply Officer, Peren, Nagaland is irregular, incorrect, illegal and contrary to the provision and spirit of the RTI Act, 2005.

AND WHEREAS, on receipt of the First Appeal, Shri. **Chubawati Chang**, NCS, Director & FAA, Directorate of Food & Civil Supplies, Nagaland, Dimapur had, after hearing of the First Appeal with the concerned parties on **12.12.2024**, passed his decision vide **No. DSE/RTI-i/2023-24/651(a)** dated **13.12.2024** directing the District Civil Supply Officer, Peren, Nagaland to furnish additional information against the unsatisfied query Nos. 05, 07, & 09 to the appellant whichever are available in the Department at the earliest.

AND WHEREAS, in compliance to the FAA's directive, Smt. **Kenyuhile Tep**, District Civil Supply Officer, Department of Food & Civil Supplies, Peren, Nagaland had, vide letter **No. SPLY/PRN/RTI/2023-24/84** dated **12.01.2025**, requested the applicant (now appellant) to come and collect the information.

AND WHEREAS, since the applicant (now appellant) was still not satisfied with the additional information furnished by the District Civil Supply Officer, Department of Food & Civil Supplies, Peren, Nagaland, he had submitted a Second Appeal dated **06.03.2025** before the Commission stating that the replies to query No. 05 & 09 were still found to be incomplete, and documents pertaining to query No. 07 were provided completely but were found to be malpractice.

AND WHEREAS, since the applicant (now appellant) is still not satisfied with the additional information furnished by the public authority, the Commission has decided to hear the above mentioned appeal by giving opportunity of being heard to all the parties on **15th April, 2025 (Tuesday)** at **12:00 Noon** in the **Hearing Room of Nagaland Information Commission, Nagaland Commissions' Complex, Below NBCC Convention Centre, New Capital Complex, Nagaland, Kohima.**

NOW THEREFORE, it is notified that the following parties are directed to appear before this Commission and **also to bring the files and relevant documents** in question for scrutiny on the above date and time for hearing.


