Subject: Closing Order of Appeal Case.

WHEREAS, the Commission had on 10/12/2024 received a second appeal dated 10/12/2024 from Shri. Mbailak Zeliang, Samziuram, Mobile No- 9383089259 & Shri. Abang Zeliang, Samziuram, Mobile No- 7085686429, against the non-response of the FAA, NSDMA, Nagaland to their First Appeal which was submitted against the non-furnishing of information by the PIO to their RTI application dated NIL.

AND WHEREAS, the applicants had submitted an RTI application dated *NIL* along with application fee of *Rs. 10/- only* to the PIO/ AP!O, Nagaland State Disaster Management Authority, Nagaland requesting the following information under Section 6 (1) of RTI Act, 2005:-

- 1. Total amount allotted for Peren District and State Disaster Management Authority (NSDMA) during the financial year 2017 till date year wise.
 - a. Construction of new structure or construction of any damage structure, location of work, name of villages where works executed since 2017 till date.
 - b. Disclose name of the contractor or any official in-charge who undertook the work.
 - c. Work undertaken in town, villag s or any repairing work during the aforementioned years.
- 2. Centrally sponsorship grants for Disaster Management allotted to Peren District under Disaster Management Fund, total amount since 2017 till date year wise.
 - a. Construction of new structure or construction of any damage structure, location of work, name of villages where works executed since 2017 till date.
 - b. Disclose name of the contractor or any official in-charge who undertook the work.
 - c. Work undertaken in town, villages or any repairing work during the aforementioned years.
- 3. Total amount of funds allotted to Peren District for natural calamities compensation since 2017 till date under District Disaster Management Fund (DDMF).
 - a. Total funds allotted to every beneficiaries, villages, towns during the above mentioned years.
 - b. List of every beneficiaries along with amount allotted for disaster relief.
 - c. Furnish list of beneficiary village wise.

Kindly provide every copies of utilisatoin certificate, completion certificate and who certified completion certificate for the work for both centrally sponsored grants and State grant under (DDMF) from year above mention

AND WHEREAS, on receipt of the above RTI application on 28/08/2024, Shri. Temsuwangshi Jamir, PIO, NSDMA, Home Department, Nagaland had vide letter No.NSDMA-RTI/585-1011/2024/1369 dated 04/10/2024, transferred the RTI application to the PIO, District Disaster Management Authority, O/o the Deputy Commissioner, Peren.

AND WHEREAS, referring to their first appeal received on 29/10/2024 Shri. Lhou chalie Viya, IAS, FAA, NSDMA, Home Department had, vide letter *No.NSDMA-RTI/585-1011/2024/1554* dated *14/10/2024* informed the applicants that the PIO had already transferred their RTI application to the PIO, District Disaster Management Authority, O/o the Deputy Commissioner, Peren under Section 6(3) of the RTI Act, 2005 with the reason stated by the PIO, NSDMA as follows:-

"The information sought in the aforesaid RTI application appears to be related to your office. Therefore, the above mentioned RTI application is being transferred under Section 6(3) of the RTI Act, 2005. It is requested to provide the required information directly to the applicants under RTI Act, 2005, subject to the provision of the RTI Act & Rules made there under"

AND WHEREAS, on not getting any information either from the FAA or PIO, the applicants (now appellants) had filed second appeal dated 10/12/2024 to the Nagaland Information Commission.

AND WHEREAS, on receipt of the Second Appeal on 10/12/2024, since no first appeal was found enclosed, the Commission had, vide letter of even No. dated 20/01/2025, requested the applicants (now appellants) to submit a copy of the first appeal and also to confirm whether the FAA had conducted hearing of the first appeal and if so, to forward a copy of the decision of the FAA to the Commission for further necessary actions.

AND WHEREAS, on not getting any response to the above directive of the Commission, the Commission had, vide letter of even No. dated 18/06/2025, again reminded the applicants (now appellants) to submit a copy of the first appeal within 15 (fifteen) days and also to confirm whether the FAA had conducted hearing of the first appeal and forward a copy of the decision of the FAA to the Commission for further necessary actions.

AND WHEREAS, though sufficient time and opportunity have been given to the applicants (now appellants) to submit their first appeal, there was no response from the applicants (now appellants) till date inspite of reminders, thus suggesting that the applicants (now appellants) have no interest to pursue their case further, and that since the case can no longer prolong indefinitely, the Commission had decided to close the case.

NOW THEREFORE, it is notified to the following parties that the Appeal case is hereby declared as **closed**:-

- 1. The FAA, Nagaland State Disaster Management Authority, Home Department, Nagaland, Kohima.
- 2. The PIO, Nagaland State Disaster Management Authority, Home Department, Nagaland, Kohima.
