

Subject: Closing Order of Appeal Case.

WHEREAS, the Commission had received a Second Appeal dated 30/01/2025 from Shri. Dziesevilie Linyu, Mobile No- 6909196672/9366939315. against the inaction of the FAA, National Institute of Medical Sciences & Research (NIMSR), Nagaland, Kohima to his First Appeal dated 04/11/2024 which was submitted against the incomplete information furnished by the PIO to his RTI application dated 23/09/2024.

AND WHEREAS, the applicant had submitted an RTI application dated 23/09/2024 addressed to the PIO, National Institute of Medica! Sciences & Research, Nagaland, Kohima seeking the following information:-

- 1. Furnish the list of MTS/ Grade-IV appointment till date along with appointment order.
- 2. Furnish in details the total number of MTS/ Grade IV post created at the Nagaland Institute of Medical Science & Research with cabinet approval order.
- 3. Whether advertisements were done in local newspaper? If yes, kindly provide photocopies of the advertisement.
- 4. Whether proper selection process/interviews were conducted? If yes, kindly provide relevant documents of selection process. Interview/ shortlist of candidates etc.
- 5. Whether any appointments were made against non-sanctioned post? If yes,
- 6. Furnish indigenous certificates, birth certificates, and scheduled tribe candidates of all MTS/Grade-IV appointed till date.
- 7. Whether reservation policies as per Government rules such as backward tribes, person with disability etc. were followed? If yes, kindly provide supporting documents.
- 8. Furnish a photocopy of the Nagaland Institute of Medical Science & Research Society by law.

AND WHEREAS, on receipt of the above RTI application, Dir. Prof. Dr. Soumya Chakraborty, Director Cum Dean, Nagaland Institute of Medical Science & Research had, vide letter No.NIMSR-10/1/RT1/2023 (pt-2)/614 dated 23/19/2024 furnished the necessary information to the applicant as below:-

AND WHEREAS, on not being satisfied with the response of the PIO, the applicant (now appellant) had submitted the First Appeal dated 04/11/2024 addressed to the FAA, National Institute of Medical Sciences & Research (NIMSR), Nagaland, Kohima stating that the information furnished by the PIO for Sl. No. 2, 5 & 6 were incomplete and hence requested to kindly intervene and inform the PIO to furnish the necessary information in detail.

AND WHEREAS, on non-response of the FAA, National Institute of Medical Sciences & Research (NIMSR), Nagaland, Kohima, the applicant (now appellant) had submitted Second Appeal dated 30/01/2025 to the Nagaland Information Commission.

AND WHEREAS, on receipt of the second appeal dated 30/01/2025, the Commission had, vide letter of even No. dated 24/02/2025, directed the Commissioner & Secretary & FAA, Department of Health and Family Welfare, who is also the Chairman, Executive Committee, NIMSR Society, Nagaland, Kohima to hear the First Appeal with both the parties i.e., the applicant (now appellant) and the PIO within 20 (twenty) days and to submit a copy of the decision to the Commission for further necessary action.

AND WHEREAS, in compliance to the Commission's directive, Shri. Anoop Khinchi, IAS, Commissioner & Secretary & FAA, Directorate of Health and Family Welfare, Nagaland, Kohima had, vide letter No.HFW(A)-12/NIMSR-RTI/215/2024(PT)/63 dated 17/03/2025, submitted that a hearing was held on 17/03/2025 at 12:30 PM and during the hearing, since the applicant (now appellant) had stated that the reply to query Nos. 3, 5 & 7 were too brief and hence needed additional information, the PIO was directed to provide the information to the applicant (now appellant) within a period of 3 (three) days.

AND WHEREAS, on receipt of the above submission of the Commissioner & Secretary & FAA dated 17/03/2025, the Commission had, vide letter of even No. dated 19/06/2025, directed the applicant (now appellant) to confirm receipt of the information from the PIO and also satisfaction or non-satisfaction of the information furnished to him within 15 (fifteen) days from the date of receipt of its directive.

AND WHEREAS, though sufficient time and opportunity have been given to the applicant (now appellant) to confirm the receipt and satisfaction or non-satisfaction of information received from the PIO, since there was no response from the applicant (now appellant) till date, suggesting that the applicant (now appellant) was satisfied and has no interest to pursue his case further, the Commission has decided to close the case. Further, the Commission also decided that no appeal from the same applicant will be entertained in future.

NOW THEREFORE, it is notified to the following parties that the Appeal case is hereby declared as **closed**:-
