Subject: Notice for a Second Hearing on 21st November, 2025 (Friday) at 11:30 AM

WHEREAS, the Commission had, on **19/08/2025** at **11:30 AM** heard the Second Appeal dated **NIL** submitted by Shri. H. Kivika Achumi, Social Activist, Mobile No. 7005320788 and Shri. Inaka Sumi, Advocate, Mobile No. 9089842001, against the unsatisfactory decision of the Chief Engineer & FAA, Water Resources Department, Nagaland, Kohima to his first appeal dated **20/05/2025** which was submitted against the unsatisfactory reply of the PIOs to his RTI application dated **NIL**.

AND WHEREAS, after the hearing of the second appeal, the Commission had passed decision vide of even No. dated **25/08/2025**, wherein:-

1. *The Executive Engineer & PIO of all districts/Divisions shall submit the information except Aadhar numbers of the beneficiaries to the directorate i.e., office of the Chief Engineer and the PIO of the Chief Engineer's office shall compile and furnish the information free of cost to the applicants (now appellants) and under intimation to the Commission, **within 10 days** from the date of receipt of the decision.*
2. *The applicants (now appellants) shall collect the information from the PIO of the Chief Engineer's office and submit their satisfaction or non-satisfaction to the PIO and with a copy to the Commission **within 14 days** from the date of receipt of the information.*

AND WHEREAS, in compliance to decision No. 1 of the Commission dated **25/08/2025**, the Chief Engineer & FAA, Water Resources Department had, vide letter **No. WRD/RTI/TECH/Case No. 2/2025/1123-25** dated **28/08/2025**, informed the applicants (now appellants) to collect the compilation of documents from the Districts PIO's for the RTI information sought.

AND WHEREAS, on receipt of the information and in compliance to decision No. 2 of Commission dated **25/08/2025**, the applicants (now appellants) had submitted a letter dated **17/09/2025** praying for extension of time to examine voluminous information furnished.

AND WHEREAS, on receipt of the above letter dated **17/09/2025**, the Commission had, vide letter of even dated **23/09/2025** granted an extension of **1(one) week** to examine the information which was furnished in compliance to its decision of even No. dated **25/08/2025** and thereafter confirm satisfaction or non-satisfaction of the information for further necessary action.

AND WHEREAS, in compliance to the Commission's directive dated **25/08/2025**, the applicants (now appellants) had, vide letter dated **NIL** (received by the Commission on **30/09/2025**) submitted that they are not satisfied with the information furnished by the PIO's of **Phek, Mon, Mokokchung, Jalukie, Zunheboto and Dimapur divisions** as they had *deliberately withheld and misrepresented critical information PMKSY fund utilization from 2019 onwards. They also stated that despite clear RTI requests, certified bank statements, UTR-confirmed payments, cheque records, receipts, acknowledgements, utilization certificates, geo-tagged photos and project details were not furnished. This constitutes suppression, misleading replies and violation of the RTI Act, raising serious concern of financial mismanagement and diversion of public funds.* A copy of the grounds for their non-satisfaction in respect of Phek, Mon, Mokokchung, Zunheboto and Dimapur were enclosed.

AND WHEREAS, since the applicants (now appellants) were not satisfied with the information furnished by the PIO's of Phek, Mon, Mokokchung, Jalukie, Zunheboto and Dimapur divisions, the Commission has decided to hear again the above mentioned appeal giving opportunity of being heard to all the parties on **21st November, 2025(Friday) at 11:30 AM in the Hearing Room of Nagaland Information Commission, Nagaland Commissions' Complex, New Capital Complex, Nagaland, Kohima.**

NOW THEREFORE, it is notified that the following parties are directed to appear before this Commission and **also to bring the files and relevant documents** in question for scrutiny on the above date and time for hearing.


