WHEREAS, the Commission had heard the Second Appeal dated 17/07/2025 on 19/08/2025 at 12:30 PM submitted by Shri. Netsozu Tunyi, Mobile No. 9612777534, Shri. stating that "the erstwhile Razu Kuhu, a welfare body of Kikruma village nominated us to conduct an Audit on V.D.B expenditure of our village in the year 2021. It may be pertinent to mention that we were not officially appointed by the district administration nor the village council. The process to audit the account was delayed as the VDB had given a reason that some of their projects were on-going and that they will submit the necessary documents after the completion of the works. In the meantime the undersigned members were also requested to audit the expenditure incurred in the construction of our village ground (The Fund of which was received as compensation during the construction of 2 Lane Road in our village). However it may be mentioned that before the completion of the audit, the internal conflict in our village led to the dissolution of the Razu Kuhu in the month of January 2024. Hence our nomination as audit committee is co-terminus with the dissolution of Razu Kuhu. Therefore sir, we would like to clarify to your office that we no longer exist as audit members in all financial matters relating to Kikruma Village."
