Subject: Closing Order of Appeal Case.

1. WHEREAS, the Commission had, on **13/02/2026 at 11:00 AM** heard the second appeal dated **30/09/2025** submitted by Shri. Japhet Chawang, Peren District, Nagaland, Mobile No. 8837290110, against the non-furnishing of information by the PIO, Peren in spite of transferring the RTI application dated **29/05/2025** by the PIO, Directorate of Rural Development on **30/05/2025** and further direction by the Director & FAA on **02/08/2025** in response to the first appeal dated **04/07/2025**.
2. AND WHEREAS, the Commission had, after the hearing held on **13/02/2026 at 11:00 AM**, passed decision of even dated **16/02/2026**.
3. AND WHEREAS, in compliance to the **Point No. 1** of the decision of the Commission dated **16/02/2026**, Shri. Rongsenmenla, NCS, Project Director & PIO, DRDA, Peren had, vide letter No. **DRDA/PRN/RTI-1/2021-22** dated **22/04/2026** submitted the web link, <https://bhuvan.nrsc.gov.in> wherein the geo-tagged photos of the project taken before and after regarding the pictorial evidences of the completed work/projects under MGNREGA of Peren district from 2008 till date are available.
4. AND WHEREAS, in compliance to **Point No. 2** of the decision of the Commission dated **16/02/2026**, Smti. Rongsenmenla, NCS, Project Director & PIO, DRDA, Peren had, vide letter No. **DRDA/PRN/RTI-1/2021-22** dated **22/04/2026** requested the applicant (now appellant) to attend for inspection of records on **30/04/2026 at 11:00 AM** in the concerned block office however, the Director & FAA, Directorate of Rural Development had, vide letter No. **DRD.RTI-AA-14/2026-27** dated **15/07/2026** forwarded to the Commission, the status report submitted by the Project Director & PIO, DRDA, Peren vide letter No. **DRDA/PRN/RTI-1/2021-22** dated **09/07/2026** wherein the applicant (now appellant) had conveyed through whatsapp message about his inability to attend and inspect the records from the concerned Block Offices, and had also enclosed a copy of the transcript of the whatsapp message.
5. AND WHEREAS, in compliance to **Point No. 3** of the decision of the Commission dated **16/02/2026**, Smti. M. Mongna Konyak, Director & FAA, Directorate of Rural Development, Nagaland, Kohima had, vide letter of even No. **DRD/RTI-AA-14/2022-23** dated **22/04/2026** submitted a copy of the treasury challan bearing challan No. 5 dated 15.04.2026 towards the penalty amount of Rs. 14,000/- which was imposed on Smti. Rongsenmenla, NCS, Project Director & PIO, DRDA, Peren, for contributing to the delay of 56 days in furnishing the information.
6. AND WHEREAS, since all the compliances have been received and that the applicant (now appellant) did not want to inspect the records allowed or invited by the PIO, DRDA, Peren, suggesting that he was no longer interested to pursue his RTI in accessing the information further, the Commission has decided to close the case.
7. NOW THEREFORE, it is notified to all the parties that this Appeal case is hereby declared as closed.

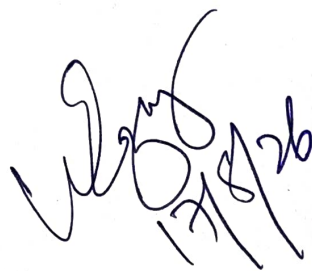
