Subject: Closing Order of Appeal Case.

WHEREAS, the Commission had, on **27/03/2026 at 11:00 AM** heard the second appeal dated **26/09/2025** submitted by Shri. Inato Chisho, Mobile No. 9863302011, Shri. Boto Y. Swu, Mobile No. 917005409209 & Shri. Zato Sumi, Mobile No. 7085702670, against non-response of the Secretary & FAA, Nagaland State Disaster Management Authority, Home Department, Nagaland, Kohima to their first appeal dated **19/08/2025** which was submitted against the non-response of the PIO, Nagaland State Disaster Management Authority, Home Department, Nagaland, Kohima to their RTI application dated **12/07/2025**.

2. AND WHEREAS, the Commission had, after the hearing held on **27/03/2026 at 11:00 AM**, passed decision of even dated **02/04/2026**.

3. AND WHEREAS, in compliance to the **Point No. 1** of the decision of the Commission dated **02/04/2026**, Shri. Temsuwangshi Jamir, PIO, NSDMA, Home Department, Nagaland, Kohima had, vide letter of even **No. 11/01/2025/018-NSDMA/783** dated **30/04/2026**, submitted copies of bills, payments vouchers, invoices and the expenditure on transportation and labour charges for the distribution of rice to the District Administration after obtaining from the respective district administration.

AND WHEREAS, in compliance to the **Point No. 2** of the decision of the Commission dated **02/04/2026**, the applicants (now appellants) had, vide letter dated **NIL**, submitted to the Commission stating that the public authority (i.e. NSDMA) had furnished the required information on **30/04/2026** and were satisfied with the information so furnished to them.

5. AND WHEREAS, in compliance to **Point No. 3** of the decision of the Commission dated **02/04/2026**, Shri. Temsuwangshi Jamir, Assistant Manager & PIO, NSDMA, Home Department, Nagaland, Kohima had, vide letter of even **No. 11/01/2025/018-NSDMA/782** dated **30/04/2026**, submitted a copy of the treasury challan bearing challan No. 35 dated **29/04/2026** towards the penalty amount of Rs. 25,000/- (Rupees twenty five thousand only) which was imposed on him for the delay in furnishing the information.

6. AND WHEREAS, since all the compliances to the Commission's decision of even No. **02/04/2026** have been received, the Commission has decided to declare the appeal as closed.
