Subject: Closing Order of Appeal Case.

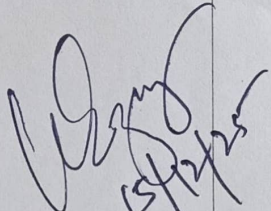
