Subject: Notice for Second Hearing on 28th August, 2026 (Friday) at 11:00 AM

WHEREAS, the Commission had, after the hearing of the second appeal dated **18/11/2025** on **15/05/2026 at 11:00 AM** submitted by Shri. Shri. Suman Dey, Astha Plaza, 4th Floor, Bora Service, GS Road, Guwahati-781007, Kamrup, Assam, Email-sumandey@cholamsispl.com, Mobile No. 7002660791, passed its decision of even No. dated **18/05/2026**.

AND WHEREAS, in compliance to **point No. 1** of the Commission's decision dated **18/05/2026**, the applicant (now appellant) had, vide letter dated **18/05/2026** submitted a copy of DL bearing registration No. NL/25456/NW/PSV/PROF/14 in respect of Shri. Simanta Saikia to the DTO, Wokha, Nagaland and with a copy to the Commission.

AND WHEREAS, in compliance to **point No. 2** of the Commission's decision dated **18/05/2026**, Shri. Bendang Longchar, District Transport Officer & PIO, Wokha, Nagaland had, vide letter **NO. DTO/W/RTI/2005/1637-3** dated **03/06/2026** submitted that after thorough review and subsequent verification with the official record, the DL belonging to Shri. Simanta Saikia bearing DL No. NL/25456/NW/PSV/14 was not issued by the DTO, Wokha and has been flagged as fake/bogus.

AND WHEREAS, on examination of the above compliances, since it was observed that the DL of Shri. Simanta Saikia bearing **DL No. NL/25456/NW/PSV/PROF/14** submitted by the applicant (now appellant) in compliance to the decision of the Commission of even No. dated **18/05/2026** and the DL mentioned in the verification report i.e., **DL No. NL/25456/NW/PSV/14** do not match and for which it could not be found in the official record, the Commission had, vide its letter of even No. dated **03/07/2026**, directed the DTO & PIO, Wokha, Nagaland to clarify the variations in the two DLs.

AND WHEREAS, in compliance to the Commission's directive dated **03/07/2026**, Shri. Bendang Longchar, DTO & PIO, Wokha, Nagaland had, vide letter **No. DTO/W/MV-8/2008/401-1-3** dated **23/07/2026** clarified that a typographical error was made during the submission of the driving license details in the official documentation in the course of verification, and had also regretfully stated that due to an inadvertent oversight, the Driving License No. was entered as NL/25456/PSV/14 whereas the actual Driving License in question should have been NL/25456/NW/PSV/PROF/14.

AND WHEREAS, the Commission has decided to hear again the above mentioned appeal giving opportunity of being heard to all the parties on **28th August 2026(Friday) at 11:00 AM in the Hearing Room of Nagaland Information Commission, Nagaland Commissions' Complex, New Capital Complex, Nagaland, Kohima.**
